# **1** Introduction

This document contains information regarding the use of E2 Solutions by users utilizing both Federal Travel Regulations (FTR) and Joint Travel Regulations (JTR). Features and options specific to JTR functionality will be indicated when possible. Additionally, many FTR and JTR features and functionality may be subject to your agency's configurations.

# 2 Before You Begin

E2 Solutions (E2) is a web-based application, accessed via a standard web browser with an internet connection.

This section lists the various browser, booking site, and desktop requirements needed to run E2. The latest system requirements information is always available to E2 users via the *Online Help* option in the <u>User Options menu</u>. Search for the keywords **system requirements** or answer **1576**.

### 2.1 Web Browsers

CWTSatoTravel recommends using a browser certified for use with E2. While other browsers are considered compatible with E2, these browsers may function, but are not fully supported.

- Certified Browsers Rigorous testing was completed on these browsers to confirm compatibility with E2 features and functions, as well as compatibility with accessibility software, such as Dragon, JAWs, and MAGic. The following browsers have been certified for use with E2:
  - o Microsoft Edge
  - Google Chrome (latest version)
  - Mozilla Firefox (latest version)
  - Apple Safari version 10

**TIP**: Brower-based "auto-complete" or "remember" functionality for forms is disabled within E2. This change, however, does not impact E2 auto-complete functionality (used for destination selection on the Site Details page, or for expense currency selection, etc.).

 Compatible Browsers – These browsers should function with E2, but they have not been certified. Special settings may be required.

**NOTE**: As of November 18, 2016, Transport Layer Security v1.2 (TLS 1.2) must be enabled for any browser to function with E2.

• Unsupported Browsers – If you are using a browser that is not certified or compatible for use with E2, you will see an unsupported browser message on the E2 login screen: The browser you are using is not supported and some features on the site may not work correctly. For the best experience, we recommend upgrading to the latest version of Edge, Chrome, Firefox or Safari.




Figure 1: Login Page — Unsupported browser message

**NOTE**: If you log in using single sign on (SSO), and you are using an unsupported browser, an unsupported browser warning message, similar to that shown, displays on your default E2 page. Additional information is available via E2 Online Help; search for answer **1576**.

# 2.2 Browser Requirements

#### 2.2.1 Features

The following features should be enabled on the browser used to access E2:

- JavaScript
- Transport Layer Security (TLS)
- Transport Layer Security v1.2 (TLS 1.2) required for access to the E2 online booking tool
- Cookies

**NOTE**: You cannot use InPrivate browsing or other browsing techniques that block cookies; E2 requires the ability to use session-level cookies.

#### 2.2.2 Pop-up Blockers

Disable pop-up window blockers or add the E2 URL to the list of allowed sites for the blocker.

#### 2.2.3 Mobile Browsers

When using a mobile browser, the following features must be enabled:

- JavaScript
- Cookies

# 2.3 Online Booking Tool Requirements

If you plan to make reservations online via the E2 online booking tool, your agency's IT department must include **\*getthere.net** in the Internet Trusted Sites. (A wildcard option is recommended as it ensures all GetThere server locations are covered.)

# 2.4 Desktop Requirements

#### 2.4.1 Monitor Resolution

E2 was designed for a minimum monitor resolution of 1024x768. If you access E2 from a device with a lower resolution (e.g., netbook, tablet), you may experience additional scrolling (including scroll bars on windows) while navigating through the content on the page.

#### 2.4.2 Magnification

When using magnification (i.e., zoom), you may experience user interface issues if you exceed these magnification maximums:

Monitor Resolution	Maximum Magnification
1024 x 768	200%
800 x 600	150%

**TIP**: If you need to exceed the maximum magnification, CWTSatoTravel recommends that you switch to an accessibility tool for support.

# 2.4.3 Adobe PDFs

E2 produces PDF documents and makes other information available in the PDF format. To view these documents, use Adobe Acrobat Reader 5.0 or higher, or another application that can view PDF files. You can download the current Adobe PDF Reader at: <a href="http://get.adobe.com/reader/">http://get.adobe.com/reader/</a>.

# 3 Logging On

When you access E2, you are prompted to log on.

**NOTE**: The login process may not apply if your agency has enabled E2 for single sign on (SSO). Always follow your workgroup's directions for E2 access.

Complete the following steps:

- 1. Enter your assigned user ID in the **E2 User Id** field.
- 2. Enter your E2 password in the **Password** field. Remember! Your password is case sensitive.
  - If you forgot your password, click the **Forgot Password?** link.
    - If you cannot remember your user ID or password, click the **Login Help** link. This link provides access to <u>user ID retrieval and password reset tools</u>.
    - If you need additional assistance, contact your minor customer point of contact. Phone number and email address information is available via the **Login Help** link.

**TIP**: For security reasons, E2 customer support cannot assist you with logon questions. You must work with your minor customer point of contact to resolve all system access issues.

- 3. Click Login (or press Enter on your keyboard).
- 4. The WARNING MESSAGE AND PRIVACY ACT NOTICE window displays once you've successfully logged on. Read the terms of use, and then click **Accept** to continue. (Per agency

policy, you are required to read and accept the terms of use each time before you can access E2.)




Figure 3: WARNING MESSAGE AND PRIVACY ACT NOTICE window

#### 3.1.1 E2 User Id and Password Assistance

Click the **Reset Password** link to reset your password, or click the **Retrieve E2 User Id** link to retrieve your user ID.

#### 3.1.2 Retrieve Phone Number

For additional assistance with password, security, or user ID issues, contact your minor customer point of contact. Using the fields in the Retrieve Phone Number section, select your hierarchy, and then click **Retrieve Number**. The number displays in the **Phone Number** field.

#### 3.1.3 Email Your Minor Customer

To request additional assistance from your minor customer contact via email, complete the required fields in this section, and then click **Send Email**.

# 4 About the E2 User Interface

The E2 user interface has common elements to help you use the interface and accomplish your tasks quickly, such as:

- Task bar
- <u>Tabs</u>
- Lists
- Collapsing and expanding sections
- Workflows and dashboards
- <u>Windows</u>

# 4.1 Using the Task Bar

The task bar provides access to all areas of the application. Your task bar is customized, based on your user type and role, user settings, and the activity that you are currently performing (such as arranging travel for another user).

The task bar is available from every page. Click a task bar tab to move to that area within the application.

#### 4.1.1 Travel Functions

The task bar includes specific travel functions, as well as access to user and administrative functions.

#### 4.1.1.1 My E2, My Approvals, Travel for Others

These options appear for all users. (If you are an approver, **My Approvals** provides access to more functions than are available to the general traveler.)

- Click <u>My E2</u> to access the Start a Travel Document section, To Do List, and lists of trips, local travel claims, and open and group authorizations. The **Trips** tab provides access to all trip documents, including authorizations, vouchers, and travel advances.
- Click <u>My Approvals</u> to review travel documents that were prepared for you by an arranger (all users) or to approve travel documents (if you are an approver).
- Click <u>Travel For Others</u> to begin a travel arranger session for another user.

#### 4.1.1.2 Audit

The Audit option appears for auditors only. It provides access to travel document audit functions.

#### 4.1.1.3 View Documents

The <u>View Documents option</u> allows you to view the travel documents of other users. (Your user configuration controls access to this function.)

#### 4.1.1.4 Administration

The <u>Administration option</u> appears for travel policy managers, credit card managers, and self-registration validators only, and provides access to system administration, credit card management, and self-registration validation tasks.

#### 4.1.1.5 *Reports*

The **Reports** option allows you to generate travel activity reports and appears for all users.

#### 4.1.2 User Options Menu

The User Options menu displays on the far-right side of the task bar. The label used for this menu is your name as it appears in E2. (This is the name used in your agency's financial system. <u>The name that you use for your reservations may differ</u>.)

Click the User Options menu in the task bar (i.e., your name), and then select from the following options.

- Click *Profile* to view or update your E2 profile, including your travel preferences.
- Click *Manage Dependents* to view or update any dependents associated with your E2 user account.

*TIP:* Refer to UG15: First Logon and Profile Updates for more information on managing your dependents.

- Click <u>Message Center</u> to view important information from your office or workgroup, agency, or E2 administrators; read selected news feeds; and access web sites approved by your agency as relevant to government travel.
- Click <u>Online Help</u> to access the E2 Knowledge Portal, where you can search for answers to your E2 questions, access computer-based training and user guides, chat with support agents, or email questions to the customer support staff.
- Click *Logout* to log out of E2.

# 4.2 Using Tabs

When multiple functions are available, E2 uses tabs. For example, My E2 provides access to five functional areas, each represented by a tab. Click a tab to move to that functional area.

Tabs are also used in the workflow dashboards and within windows.

#### 4.2.1 At a Glance

The <u>At a Glance tab</u> is the default starting page. This tab provides:

- Quick links to the most popular actions, such as shopping for flights and hotels, creating an authorization, or searching for a trip
- Your To Do list for upcoming travel and document deadlines
- Important notifications from your office or workgroup, agency, or E2 administrators

#### 4.2.2 Trips

The <u>Trips tab</u> displays all of your current trips in a sortable list. This tab provides access to:

- Trip documents, such as authorizations, vouchers, and advances
- Actions, such as create a new authorization, copy a trip, and show reservations

#### 4.2.3 Local Travel

The Local Travel tab displays all of your current local travel claims in a sortable list. This tab provides access to:

- Local travel claims
- Actions, such as create a new claim or copy a claim

#### 4.2.4 Open Authorization

The <u>Open Authorization tab</u> displays all of your current open authorizations (OAs) in a sortable list. This tab provides access to:

- OAs
- Actions, such as create a new OA, create a trip under the OA, or copy an OA

#### 4.2.5 Group Authorization

The <u>Group Authorization tab</u> displays all of your current group authorizations (GAs) in a sortable list. This tab provides access to:

- GAs
- Actions, such as create a new GA or copy a GA

### 4.3 Using Lists

Lists are found throughout E2. For example, the **Trips** tab shows all of your current trips sorted by the departure date. Similar document lists appear on the **Local Travel**, **Open Authorization**, and **Group Authorization** tabs.

#### 4.3.1 Document Lists

Document lists show you basic information about each item, and may provide links to actions, such as show, delete, or copy. The list on the **Local Travel** tab, for example, displays the following information about each local travel claim:

- Claim Id A unique string identifying your claim.
- Start Date and End Date The starting and ending dates of your claim.
- Purpose The purpose of your local travel.
- Status The status of your claim (e.g., Open Voucher, Pending Voucher Approval).
- Approver The name of the approver, for claims in the approval process.
- Show Click this link to access the local travel claim workflow.
- **Copy Trip** Click this link to create a new claim by copying the existing claim, changing on the starting and ending dates.
- Archive Click this link to remove paid claims from your current claims list.

### 4.3.2 Expenses and Account Code Lists

Within the authorization, voucher, and local travel workflows, items such as expenses and account codes appear in lists. Like document lists, these lists also show specific item information and may include a variety of links.

#### 4.3.3 Auto-Complete Lists

Workflow pages also contain fields that generate auto-complete lists. Enter a few characters in the field and a matching list displays. Click an entry to populate the field with that value. Auto-complete lists are available for location fields (e.g., the Site Details page in the authorization workflow) and currency codes.

#### 4.3.4 Multiple Page Lists

If a list spans multiple pages, navigation links display at the bottom of the list. Depending on where you are in the list, however, certain links may not display. The **<< First** link, for example, does not display if you are viewing the first page of a list.

- Click **25** or **50** to increase the number of list items per page. By default, multi-page lists show only ten items per page.
- The Showing statement indicates where you are in the list.
- Click << **First** to view the first page in the list.
- Click < **Previous** to view the previous page in the list.
- Click a specific page number to view that page. (The page you are on is displayed in bold type and is not an active link.
- Click **Next >** to view the next page in the list.
- Click Last >> to view the last page in the list.

#### 4.3.5 Sorting

E.

By default, lists are sorted and displayed in a logical order, typically by date. You can, however, change the sort order to meet your preferences. Complete the following steps.

- 1. Select the column to use for sorting from the **Order by** drop-down list.
- 2. Click the appropriate **Sort** button to reorder the list.
  - **Sort Ascending** Click this button to sort alphabetical fields from A to Z, numeric fields from smallest to largest, and date field from oldest to newest (e.g., from 02-Jun-2017 to 12-Mar-2018).
  - Sort Descending Click this button to sort alphabetical fields from Z to A, numerical fields from largest to smallest, and date fields from newest to oldest (e.g., 23-Aug-2017 to 01-Jan-2016).

#### 4.3.6 Filtering

E2 provides filters to help you quickly find specific items in a list. Filters are available from an expandable **Filter Options** tab, located above the sort order field options.

- 3. Click **Apply Filter**. An item must match all of the selected options to be included in the list.
  - To see more items without scrolling, collapse the Filter Options section; click the Collapse indicator (
  - To remove all filters and return to the default display, clear all of the filter options and click **Apply Filter**.
  - If you make changes to a list, and then want to filter that list, before sure to save your changes first.

# 4.5 Workflows and Dashboards

Each time you create a travel document (e.g., authorization, voucher, local travel claim), you enter a document workflow. Each page you encounter is a step in the workflow, and includes the following elements:

- Left-side navigation and links to optional features, functions, and secondary actions
- <u>Header</u> with general traveler and document information
- <u>Main information area</u>, where you enter or select information
- Buttons and links, below the main information area, allow you to complete the step

- <u>Dynamic message area</u>, which appears below the header and may include agency- or workgroup-specific information, warnings, or errors
- Help icon (100) links to online help for the page or window

**NOTE**: For improved usability, E2 provides hover text for all links, buttons, fields, and list selections.

#### 4.5.1 Left Side Navigation

The left side of the page provides links to navigate the main workflow process and to perform other related functions. Left side navigation includes:

#### 4.5.1.1 Workflow Steps

Each step is a link and can be used to go to that place in the workflow, when necessary. Workflows are dynamic: some actions may insert steps in the workflow. For example, if you add an advance request to your travel authorization, two steps are added to the authorization workflow. You must complete the first workflow step (i.e., Basic Information) before the other workflow steps are enabled.

Common Other Actions links for all workflows include:

- Attachments Allows you to view or attach receipts and other supporting information to the document.
- History (View Claim History for local travel claims, and Trip History for authorizations, vouchers, and travel advances) – Allows you to review a log of actions associated with the document.
- Printable (Printable Authorization, Compact Printable Authorization, Printable Travel Advance, Printable Voucher, Compact Printable Voucher, Printable Local Voucher) Provides access to the document in a printer-friendly format.
- Remarks Allows you to view or add remarks to the document.
- View Routing History Allows you to review a log of routing events associated with the document.
- View Routing Path Allows you to see the document's approval path. This link is only available after the document has been submitted for approval and is in a *Pending Approval* status.

#### 4.5.1.3 *Extras*

Links to additional actions. These links may take you out of the document workflow. Common Extras links include leaving the workflow to view a document list or deleting the current document.

#### 4.5.2 Document Header Information

The header section displays just below the page banner on every workflow page. Every header includes the following information:

- Name of the traveler
- Trip or claim ID
- Status information

Depending on the document type, additional information may also appear in the header.

For example, from the main area of the Authorization Accounting page, you can:

- Click the Select Account Codes link to choose funding for your expenses.
- Click the Split Funding link to split funding for estimated expenses by expense type or date.
- Click a link in the Account Code column to view account code details.
- Specify the amount or percentage of expenses to allocate to the account.
- Add an account to a favorites list.
- Delete an account code from the document.

#### 4.5.4 Buttons and Links

Buttons and links display at the bottom of the main area.

- When you have completed entering or selecting information, click the primary button (always shown in bold and on the left) to continue to the next step in the workflow. In the previous figure, **Save and Next Step** is the primary button.
- Secondary buttons are shown just to the right of the primary button. In general, a secondary button allows you to save your entries/changes without moving to the next step in the process. In the previous figure, the **Save** button is the secondary button.
- Links allow you to return to the previous step. In the previous figure, the **Back to Step 2: Expenses** link returns you to the Expenses page.

**TIP**: Be sure to save any information you have entered before you return to a previous step, or that information will be lost.

#### 4.5.5 Messages

Informational, success, warning, and error messages are shown in the message area, just above the main area. This area only displays when a message is available for the page.




Figure 28: Success Message

#### 4.5.6 Dashboards

In E2, authorizations, vouchers, and travel advances are individual documents. In combination with other items, such as reservations and comparative trips, these documents represent your travel plans, actual travel activity, and expenses. This combination of documents is known as your trip.

When you create an authorization, you are taken directly into the authorization workflow. After you have completed the first step in the process, the authorization is assigned a trip ID and a **Trip Dashboard** tab displays. The trip ID is a unique identifier that is used to track all of the individual documents the combine to represent the trip, while the **Trip Dashboard** tab provides a single access point for all of those documents.

Dashboards allow you to access individual documents and take actions that may impact multiple documents. They also allow you to create new documents. For example, you can create vouchers and travel advances, as well as amend an authorization, from the **Trip Dashboard** tab. Dashboards are available for:

- Trips
- Open authorizations
- Group authorizations

# 4.6 Using Windows

When you add or edit expenses, for example, or select account codes for a document, you are using a modal window. This is a special kind of window that appears in front of the current page; E2 does not respond to any event (e.g., mouse click, keyboard input) other than those events associated with the window. The window blocks the workflow process until it is closed.




Figure 37: Window ready to be moved

#### 4.6.1 Tabs

Many of the windows in E2 workflows have tabs. These tabs allow you to perform multiple functions; click a tab at the top of the window to switch functions.

For example, the Edit Expense window for a voucher has three tabs: **Detail**, **Remarks**, and **Receipts**. When you edit an expense on a voucher, the **Detail** tab displays by default. To add remarks or attach documents, click the appropriate tab. (The tab that appears by default varies depending on the requested action.)

### 4.7 Scrolling

When the size of a page exceeds the browser window size, the browser displays scroll bars. Scroll bars may be horizontal or vertical; use the scroll bars to see the whole page.

Depending on the contents of the E2 window and the size of the viewable area, the E2 window may have both "content" scroll bars and viewable area scroll bars (like the browser window scroll bars). If you are using E2 from a computer that is configured for less than the minimum supported screen resolution of 1024x768, or if the browser is set to greater than 100% zoom, E2's windows may exceed the size of the viewable area. If this occurs, the E2 window will have scroll bars to provide the user access to all portions of the window. Like browser window scroll bars, the E2 window may have both vertical and horizontal scroll bars.

# 5 Selecting a Default Landing Page

The My E2 **At a Glance** tab is your default landing page. As you use E2, however, you may find that you would prefer to see a different page first when you log in. As a traveler, for example, you might want to see a list of your active trips; approvers might choose to see the list of documents pending approval.

**TIP**: You are the only one who can change your default landing page, and you can change it at any time. A travel arranger cannot make that change for you.

You can designate any of the following as your default landing page:

- My E2 tabs (At a Glance, Trips, Local Travel, Open Authorizations, or Group Authorizations)
- My Approvals
- Travel for Others
- Reports
- Message Center (Bulletins, News & Alerts, or Agency Links tab)

**NOTE**: If you have access to the **Audit** and **View Documents** options on the task bar, either page can also be designated as your default landing page. If you can access the **Agency Hierarchy** link (from the **Administration** option), that page can also be set as your default landing page.

# 6 Introducing My E2

My E2 provides access to all of your travel-related documents. It also provides quick access to items requiring your immediate action via the **At a Glance** tab. My E2 includes the following tabs; to access any of these tabs, click **My E2** on the task bar.

- <u>At a Glance</u> Items that require your immediate attention
- Trips Trips list and access to common trip-related functions
- Local Travel Local travel (LT) claims list and access to common LT functions
- Open Authorization Open authorizations (OA) list and access to common OA functions
- Group Authorization Group authorization (GA) list and access to common GA functions

# 6.1 At a Glance Tab

The **At a Glance** tab is the default landing page when you first log on to E2. This tab provides one-click access to items that require your attention, including:

- Quick links to common tasks, such as shopping for a reservation, creating a new authorization, or creating a local travel claim
- A to-do list of documents that require completion
- Notifications, including urgent communications from your agency, pending approval information, and notification of other items that require your attention, such as overdue travel advances or held reservations that require action to prevent cancellation fees

#### 6.1.2 To Do List

When you first log on to E2, your To Do List displays a welcome message and may prompt you to complete your user profile. After using E2, your To Do List displays items that require completion. The list displays a maximum of eight items, and items are sorted according to the relevant date information, such as the upcoming departure date or number of days after travel has been completed. Click any link in the list to go directly to that document's workflow.

#### 6.1.3 Notifications

The Notifications section on the **At a Glance** tab displays bulletins, pending approvals, and additional notices that may be of interest to the traveler.

#### 6.1.3.1 Bulletins

Bulletins are urgent messages from your agency, office or workgroup, or E2 system administrators. Up to three bulletins may be listed in this section, ordered by the message release date.




Figure 53: Local Travel tab — Claim Status icons

- For *approvers*, this section provides access to all travel documents that require your approval. Use the search and filter options to limit the displayed list and quickly locate specific documents for approval.

- 3. Click the **Show** link to open and review the document.

## 7.2 Travel for Others

The Travel for Others feature allows those users with arranger access, or who have been selected as an arranger by a traveler, to make trip arrangements or take other actions for another user.

- Travelers can select other users to perform travel arranger functions on their behalf in their E2 user profiles. These users are referred to as *designated travel arrangers*. As a designated travel arranger, you can arrange travel for the person who selected you as an arranger. (You can be a designated travel arranger for one person or multiple people.)
- Your office, workgroup, or agency may permit select users to arrange travel for travelers within their group, without being designated as an arranger in each traveler's E2 user profile. A user with this permission has the role of arranger.

**NOTE**: An error message (You are not an arranger for any traveler) displays as you access the Travel for Others page if you do not have arranger access and you are not listed as an arranger for any travelers. This message is informational only and no further action may be taken on the page. If you believe you should be able to access the Travel for Others page, contact your system administrator for assistance.

#### 7.2.1 Search for a Traveler

When you access the Travel for Others page, the search results are automatically populated, based on your arranger access.

- If you have arranger access privileges, the search results list all users for whom you can arrange travel based on those privileges.
- If you have no arranger access privileges, the search results list all users for whom you are a designated travel arranger.

#### 7.2.2 Arranger Session

Click the **Arrange** icon for a traveler listed in the search results on the Travel for Others page to start arranging travel for that user. You can tell that you are in an arranger session by the task bar, which is limited to two selections:

- Traveler's Trips Click this option to view the traveler's My E2 tabs (i.e., At a Glance, Trips, Local Travel, Open Authorization, and Group Authorization). When you begin an arranger session, the traveler's At a Glance tab displays by default.
- Traveler's Profile Click this option to open the traveler's profile.
- **Traveler's Dependents** If the Dependent Travel feature is enabled, click this option to open the Manage Dependents page and manage the traveler's dependents.

The label on the User Options menu identifies you as well as the traveler for whom you are arranging travel (i.e., *Traveler's Name // Your Name*). As an arranger, you can take most of the same actions for the traveler as you can take for yourself. You cannot, however, change the traveler's default landing page.

To exit the arranger session, click the User Options menu, and then select *Stop arranging for* from the drop-down list. You are returned to your E2 session, at the Travel for Others page, and your normal task bar functions are again available.

## 8.2 Administration

The **Administration** option appears as a task bar selection if you are an E2 travel policy manager (system administrator), or if you perform credit card management or self-registration validation activities.

Travel policy managers perform a variety of administrative tasks, including office and workgroup settings, user creation and configuration, financial system settings, fund maintenance, document routing configuration, charge card management, and message maintenance. The **Administration** option provides access to all of the administrative functions available to you as an E2 travel policy manager.

## 8.4 Profile

The *Profile* option appears in the <u>User Options menu</u> for all users. Your profile contains a variety of information about you and your travel preferences. You can enter and change some information in your profile; other information may have been entered for you or may be controlled by your agency or system administrator.

When you first log on, a message on the **At a Glance** tab prompts you to complete your profile. A profile is incomplete until it includes address information. At the minimum, however, the following sections must be completed before you can take any travel-related actions within E2:

- Address Information
- Email Information
- Approval Routing

**NOTE**: This is added by your system administrator. Click the **View Approval Routing** link in the Other Features section to review your approval routing information.

Your agency may also require the following sections to be complete:

- Credit Card Information
- Travel Preferences

**TIP**: If you plan to book reservations via the E2 online booking tool or via a request to your TMC, you should also verify the reservation name in the Personal Profile section. This is the name used for your reservations and should match the government-issued document that you use when traveling. This is part

of the government's Secure Flight initiative, and inaccurate information may result in additional Transportation and Safety Administration (TSA) screenings at boarding, or even denial to board.

Complete the following steps to view or update your E2 profile:

- 1. Click the User Options menu in the task bar (i.e., your name).
- 2. Select *Profile* from the drop-down list. This displays your User Profile page.
- 3. Click the link to the right of each section to view or update that information.




Figure 77: Online Help — Subscription Confirmation window




Figure 78: Online Help — Contact Us menu




Figure 85: Mobile Online Help — Search

# 11 E2 Glossary

# Account Code

An account code string corresponds to the funding organization for your travel. The segments that make up each account code determine how the expenses on trips, vouchers, advances, and local travel claims will be funded.

**NOTE**: If you do not know the appropriate account code to use for a travel document or expense, or you cannot find the correct account code, contact your manager or other agency personnel for assistance.

#### Tips

- Account codes and their formats are specific to each agency and are a function of the agency's financial system. You can click any account code (in the Accounting workflow step or in the Account Code Selection window) to view additional information about that particular account code.
- Use the Favorites feature, if supported by your agency's travel policy, to maintain a list of favorite account codes. Standard account codes can be added to your Favorites list through your profile or from the Accounting workflow page after an account code has been selected.

# Actual Expenses

The *Actual* expense reimbursement type allows you to claim actual trip expenses rather than be limited to per diem rates. Actual expenses can be higher or lower than a site's per diem rate, but total expenses for a site cannot exceed travel policy limitations. (Travel policies differ; always consult your agency travel policy for limitations and other details.) Actual lodging expenses may also be limited to a specific amount based on the maximum lodging per diem rate for a site.

You can select a reimbursement type for each day of travel, for both lodging and meals and incidental expenses (M&IE), on the authorization's Expenses step.

#### **Changing Reimbursement Types**

If you need to change the reimbursement type after an authorization has been approved, you must amend the trip. For example, if your lodging rate exceeded the per diem allowance, and your agency approved the excess expense, you would amend your trip and change the reimbursement type for your lodging to *Actual*. After the amended trip is approved, you can enter your actual expenses and submit the voucher for approval.

#### **Actual Reimbursement Maximum**

When *Actual* has been selected from the **Reimbursement Type** drop-down list for at least one day in the authorization's Lodging Expenses or Meals and Incidental Expenses window, the *Actual Reimbursement Maximum* text displays at the bottom of the window.

The number to the right of the text indicates the percentage by which actual lodging and meal expenses can exceed the per diem amount, as defined for your office or workgroup. There may be scenarios, however, where the percentage allowed for actual expenses needs to be adjusted for a particular trip. Click the **Modify** link to display the Actual Reimbursement Maximum window, which allows you to edit the maximum percentage allowed.

**NOTE**: The **Modify** link will not display when you are amending the authorization if at least one closed voucher already exists for the authorization. The Actual Reimbursement Maximum value established with the original authorization will be carried forward to the amendment and any

future vouchers, but you will not be able to modify the maximum percentage allowed on the amendment.

# Administrator

Also known as the <u>Travel Policy Manager</u>.

An administrator is an E2 user within an organizational structure that has a specific set of advanced permissions. Administrators can assist you with travel policy questions specific to your agency, as well as with other issues related to E2 features and functions.

# Airline Change Fee

When a traveler requests a change to a ticketed transaction, an airline change fee may be charged to the travel agent by the airline carrier if the agent does not reissue the ticket. This fee may be passed onto you as an expense to be included with your authorization or voucher.

**NOTE**: The airlines are not charging the government for this change fee. Instead, the airlines are charging this fee to the travel agent if, and only if, the agent does not reissue the ticket when a change is made after the ticket has already been issued.

If a travel agent does not reissue the ticket and officially change the record, the airline will not be able to determine if a flight is overbooked, or if additional funds should be collected or refunded as a result of the change. Additionally, when the traveler checks in, that person's record will not show the most recent changes, which could impact the traveler's ability to board the flight.

An airline change fee is not imposed when the travel agent reissues tickets to reflect voluntary changes.

# Approval Routing

Approval routing refers to one or more approval steps for a type of document configured by an administrator and based on agency travel policy. Approval routing may be configured at the individual traveler level, or configured at a hierarchy level and applied to all traveler documents within that hierarchy.

#### **Approval Path**

A document may follow multiple steps on the path to approval. To view the approval path for a document that is pending approval, open the document and click the **View Routing Path** link in the Other Actions section.

**NOTE**: The View Routing Path link is only available for documents with a Pending Approval status. To view approval routing information that is generally applicable to a traveler's documents, click the View Approval Routing link in the Other Features section of the traveler's profile.

#### <u>Approver</u>

Also known as a "Federal Supervisory Travel Approver."

An approver can approve, revise, route, and print travel documents for users within a specified approval hierarchy.

# <u>Arranger</u>

See <u>Travel Arranger</u>.

## Arranger Session

When you click the **Arrange** icon for a traveler listed in the search results on the Travel for Others page, you enter an arranger session where you can start arranging travel for that user. You can tell that you are in an arranger session by the task bar, which is limited to two selections: **Traveler's Trips** and **Traveler's Profile**. The label on the User Options menu also identifies you as well as the traveler for whom you are arranging travel (i.e., *Traveler's Name // Your Name*).

As an arranger you can take most of the same actions for the traveler as you can take for yourself — create a travel document, make reservations, etc. (You cannot, however, change the traveler's default landing page.)

# <u>Auditor</u>

Depending on customer policy settings, auditors perform audits to ensure adherence to such items as:

- Agency expense policies
- Usage of proper accounting strings
- Corroboration of expenses with attached receipts
- Review of remarks and document history to assure that other trip guidance has been followed
- Comparison with other travel team documents

Your workgroup can have only one type of audit enabled: pre-payment or post-payment.

- Pre-payment audits take place after a voucher has received final approval but before funds are reimbursed.
- Post-payment audits take place after a voucher has a status of Closed Voucher.

#### Access

To access audit functions, you must be assigned a user role of *Auditor*, click **Audit** on the task bar to access auditor functions. Refer to *UG49: Auditing Vouchers* for more detailed information on the audit process.

# Authorization

See <u>Travel Authorization</u>.

# Authorized Delay

An authorized delay is an allowed delay that occurs when you are not directly traveling to your destination. An allowed delay may occur when using any mode of transportation, for any reason. Examples include:

- Weather
- Traveling OCONUS on flights with stopovers exceeding 14 hours
- Traveling using a personally owned vehicle (POV) to a location that is more than 350 miles away

# Automatic Log Off (Inactivity)

The default inactivity time is 15 minutes. This is also the maximum time of inactivity; your group may have a shorter period of inactivity. E2 displays a window notifying you of inactivity. Click **OK** to stay logged on.

# Blanket Travel Authorization

See Open Authorization.

# <u>Break</u>

A break is defined by the FTR as time off from an extended temporary duty assignment (TDY), so you can return to your home site for official duty. (Refer to <u>FTR §301-11.21 through §301-11.24</u> for details.)

#### Reimbursement

Per diem is paid at a rate of 75% on the day of your return to the home site and the day of your return to the TDY site.

If you leave your home site and travel to a TDY site on one day, and then return to your home site on the next day, and the time period that you are gone is greater than 12 hours, but less than 24 hours (i.e., the trip spans two calendar days), the amount of reimbursement you receive depends on whether lodging was required. For example, if you begin travel at 10pm and return to your home site the next morning, you are reimbursed as follows:

- If you do not book a hotel, you are reimbursed for one day of leave at 75% of the meals and incidentals expenses (M&IE) rate only.
- If you book a hotel, you are reimbursed for two days of leave at 75% of the M&IE and lodging rates.

#### Versus "Leave"

A break is different from a leave. The FTR defines "leave" as a personal break in official duty while at a temporary duty (TDY) station. Official days off (also known as "leave days") are normal workdays (e.g., non-holiday, non-vacation) during a trip that should not be considered workdays.

#### Add Break

The ability to add a break to your trip is controlled by your workgroup's travel policy. If the **Add Break** button does not appear on the Site Details step of the authorization workflow, your group's travel policy does not permit you to add a break in your TDY travel.

# <u>Cancel</u>

Canceling a document in E2 removes the document from use, but retains the document information for audit purposes, based on government requirements. If you cannot delete a document because it does not have a *New* status, you can usually cancel the document. Look for the **Cancel** link in the Extras section of the document workflow or dashboard.

### **Document Status**

If the **Cancel** option is not available to you, review the document's status. You cannot cancel a document if it is pending approval or if an associated trip document is pending approval. If you need to cancel a document that is pending approval, recall the document. After the document is recalled, you can cancel it.

# Charge Card Payment

Total entitlements are calculated after your voucher or local travel claim is complete. Depending on your travel policy and method of reimbursement ("Pay To") selections, two payments may be issued – one to you and one directly to the charge card company.

Method of reimbursement selections are required as part of the Expenses step in the voucher and local travel claim workflows. In some cases, you may be allowed to have some expenses that are reimbursed to the traveler paid directly to your travel charge card.

**NOTE**: Please contact your finance officer for any questions regarding charge card and other payments.

# Coach Class

Also known as "economy class."

Coach class is the basic accommodation class offered by commercial airlines and passenger rail carriers. This class includes a service level available to all passengers regardless of the fare paid.

The term applies when an airline offers only one accommodation class that is sold as economy-class. It also includes tourist class and economy class on commercial airlines, and reserved coach and slumber coach accommodations on overnight rail travel.

**NOTE**: Some airlines only offer a single level of accommodation, but that level is true business class or true first class. Do not confuse these carriers with airlines that offer only one economy class accommodation class.

"Premium economy class" is offered by some airlines as more of an elite, "other-than-coach," travel class between the true coach or economy class and business class. Your agency may permit you to book fares in this class in accordance with internal policies and procedures, but justification and an explanation may still be required on the authorization's Travel Policy page. Contact your agency's travel policy manager for more information.

# Commercial Auto

Also known as "special conveyance" or "rental car."

A commercially rented or hired vehicle, other than a privately owned vehicle, and other than those vehicles owned or under contract to an agency.

# Common Carrier

Also known as commercial transportation.

"Common carrier" refers to commercial air, rail, bus, or ship transportation supplied by the private sector. If allowed by your agency's travel policy, commercial airfare and rail may be booked via E2 using the online booking tool. You cannot, however, book bus or ship/vessel transportation online in E2. Contact your travel management center for assistance with these forms of transport.

**NOTE**: Travel by ferry may be considered a commercial vessel. Ferry fees may also be considered a privately owned vehicle expense. Contact your travel policy manager for guidance.

## Comparative Airfare

If you are not traveling via commercial air or a "government" mode of transportation (i.e., government plane, government vessel, etc.), the Comparative Airfare feature allows you to see the cost of coach commercial airfare for a matching itinerary. Comparative airfare information includes the full airport names and codes for each itinerary segment.

### Link

The **Comparative Airfare** link is available in the Other Actions section, on the left side of pages in the authorization workflow. The link is also controlled by travel policy and may not be available to all users. If your policy supports the required use of this feature, the **Comparative Airfare** link is available:

- To all users with access to the authorization, including travelers, arrangers, approvers, and auditors
- After the authorization Site Details step is completed and saved (site locations must be associated with an airport)
- If the mode of transportation is commercial auto, commercial bus, commercial rail, commercial vessel, private motorcycle, private plane, or private auto

Complete the following steps to utilize the Comparative Airfare feature:

- 1. Open your trip and view the authorization.
  - a. Click the My E2 **Trips** tab.
  - b. Locate the trip.
  - c. Click the **Show** link.

*TIP*: If necessary, click the *Trip Dashboard* tab, find the authorization in the Authorization section, and then click *Show*.

 Click the Comparative Airfare link, in Other Actions, on the left side of any workflow page. This displays the Comparative Airfare window. The total amount includes all segments shown; in the following figure, the round-trip cost is \$258.00 (excluding taxes).

NOTE: Comparative airfare is not available if the travel dates have passed.

3. Click Exit Window to close the window and return to the authorization workflow.

### Comparative Trip

A comparative trip is an alternate travel scenario that is used for comparison purposes during the authorization approval process. It includes basic information (i.e., type of travel and travel purpose), site details, and expenses. For example, you could add a comparative trip with a different mode of transportation than the authorization, alternate per diem locations, or even different travel dates.

#### Link

You can add a comparative trip to your authorization after you complete *all steps* in the authorization workflow and before you submit the authorization for approval. Click the **Add Comparative Trip** link in the Extras section on the authorization's Summary page.

- You can add up to two comparative trips to your authorization.
- A comparative trip can use the existing authorization as a template, so you only need to make changes, or you can add all comparative trip details manually.
- Comparative trips are only available if this feature is enabled for your workgroup. If the Add Comparative Trip link is not available, you do not have access to this feature. Contact your travel policy manager for assistance and next steps.

Comparative trip information, once created, is available from the **Trip Dashboard** tab, as well as from links on the authorization's Summary page. Comparative trips are assigned a comparative trip ID, which appears in the page header of all pages in the comparative trip workflow, along with the traveler's name and associated trip ID.

## **Contract Carrier**

A contract carrier is an airline that has a government contract to service a specific route at a contracted rate. In the online booking tool (OBT), the "Contract carrier" symbol ( **Contract carrier** ) identifies contracted fares available for government travelers. These contracted fares are part of the government's

City Pair Program (CPP), which offers fares that are considerably lower than comparable commercial fares.

Contract city pair fares may be used by federal and DOD civilian employees (but not federal contractors) on official travel, uniformed service members and reservists in active status, and dependents of federal employees or active duty military, if their names are on the official travel orders. Use of a contracted fare is preferred when booking travel through E2 as they provide the following advantages:

- No advance purchase restrictions
- No minimum or maximum length of stay required
- Tickets are fully refundable
- Government fares offer last seat availability
- No blackout periods
- Stable prices enable travel budgeting
- Dual fare availability (-CA and YCA)

Selection of a non-contract fare is considered out of policy and will require justification.

#### **Fare Types**

The following types of fares may be seen when booking air travel through E2.

#### -CA & YCA Fares

These are fully refundable, unrestricted, contracted government fares that are within travel policy.

- -CA fares are typically lower than YCA, but there is limited seat availability for these fares. (Seat availability on a particular flight varies by carrier and market.)
- -CA fares allow an agency to save the most money possible, while still enjoying the same quality service available with the YCA fare. Preference should be given to –CA fares; if both –CA and YCA fares are available, travelers should book the –CA fare.

#### **Coach Fares**

A Coach fare is typically the lowest commercial fare for the selected flight.

- May be issued within a 24-hour period, based on the airline, to guarantee the ticket (see fare rules).
- Unrestricted coach fares are fully refundable. After the unrestricted coach fare ticket is issued, it can be refunded. (Booking fees, however, still apply.)
- Restricted coach fares may not be fully refundable (see fare rules).

#### DG Fares

DG fares are offered by non-contract carriers but are not available to the general public. Therefore, these fares do not qualify for the FTR exception that allows government travelers to take advantage of a lower commercial fare offered by non-contract carriers. Some things to be aware of before booking a DG fare:

- May not be used for government travel, unless it meets a government exception.
- May change price between the time the reservation is made and the ticket is issued.
- May add additional fees that do not apply to contract airfares.
- May charge early ticketing to a traveler's credit card sooner than with contract airfares.

DG fares may be used when any of the following conditions are met:

- A contracted City Pair fare is not available.
- Space or scheduled contract flight is not available in time to accomplish the purpose of your travel.
- Contract flight is inconsistent with explicit agency policies regarding scheduling travel during normal working hours.
- Rail is not available, not cost effective, or inconsistent with mission requirements.

# <u>CONUS</u>

"CONUS" is a designation for travel occurring within the continental United States. The U.S. General Services Administration establishes CONUS per diem rates.

*TIP*: You can search for and view current per diem rates through the **Agency Links** tab in the E2 Message Center. Select Message Center from the User Options menu on the task bar, click the **Agency Links** tab, and then select the link for <u>GSA per diem rates</u>.

# Custom Sites and Per Diem Rates

E2 supports custom sites, defined by your agency and associated with custom per diem rates. The agency controls the number of days at a site and the applicable per diem rates. The following types of custom sites can be configured:

- Fixed custom sites These are custom sites associated with a fixed per diem rate for lodging and meals and incidental expenses (M&IE).
- Flat custom sites These are custom sites associated with a flat per diem rate for lodging and M&IE. The agency defines a flat M&IE per diem rate for all travel days and may define a different M&IE per diem rate for non-travel days.
- Variable custom sites The lodging and M&IE per diem rates may vary based on the length of stay at the site. (Standard first and last day of travel rules apply.) For example, if you are at a site for 90 days:
  - $\circ$  Days 1 through 30 may be at a specific per diem rate.
  - Days 31 through 60 may be at a second per diem rate.
  - Days 61 through 90 may be at a third per diem rate.

#### Mileage Rates

Custom sites may also control the mileage rates for use of privately owned vehicles. Mileage rates may be fixed or may vary, based on the number of days at the site.

#### Site Details

When you create an authorization, always verify the sites for your trip are correct at the Site Details step. If you have booked reservations, but are required to use a custom site, enter the first few characters of the custom site name in the **Going To** field, pause, and then choose the correct site from the list.

### Daily Expenses Summary

To review per diem information for each site and day of your trip, click the **Daily Expenses Summary** link in the Other Actions section for an authorization or voucher.

# <u>Dashboard</u>

A tab in an E2 document workflow that allows you to access individual documents and to take actions that may impact multiple documents. The dashboard also allows you to create new documents. Dashboards are available for:

- Group authorizations
- Local travel claims
- Open authorizations
- Trips

### Access

Complete the following steps to access a dashboard.

- 1. Click My E2 in the task bar.
- 2. Click the tab for the appropriate document list. For example, click the **Trips** tab to see the list of your trips.
- 3. Locate the item on the list.
- 4. Click the **Show** link. Depending on the document's status, either the document's workflow or the **Dashboard** tab displays. If you see the document workflow, click the **Dashboard** tab.

### Example

In E2, authorizations, vouchers, and travel advances are individual documents. In combination with other items, such as reservations, these documents represent your travel plans, actual travel activity, and expenses. This combination of documents is known as your trip. The **Trip Dashboard** tab allows you to view and execute actions related not just to a specific document, but to your trip – which may impact several documents.

For example, when you create an authorization, you are taken directly into the authorization's workflow. After you have completed the first step in the process, the authorization is assigned a trip ID. This ID number is a unique identifier that is used to track all of the individual documents that combine to represent the trip. When you access the authorization again, you will see a tabbed interface that includes two tabs: **Trip Dashboard** and **Authorization**.

## <u>Delete</u>

Deleting a document in E2 removes it from the system. You can only delete a document if it has a *New* status (i.e., was never submitted for approval). If you are unable to delete a document, you can usually cancel it.

# <u>Dependent</u>

A dependent is any person who meets one of the following criteria:

• A child of the employee, employee's spouse, or employee's domestic partner, who is unmarried and under 21 years of age or who, regardless of age, is physically or mentally incapable of self-support

**NOTE**: The term "child" includes natural offspring; stepchildren; adopted children; grandchildren, legal minor wards, or other dependent children who are under legal guardianship of the employee, employee's spouse, or employee's domestic partner; and any unborn child(ren) born and moved after the employee's effective date of transfer.

- A dependent parent (including step and legally adoptive parents) of the employee, employee's spouse, or employee's domestic partner
- A dependent brother or sister (including step and legally adoptive brothers and sisters) of the employee, employee's spouse, or employee's domestic partner, who is unmarried and under 21 years of age or who, regardless of age, is physically or mentally incapable of self-support

# **Dimensional Account Codes**

Rather than selecting from a list of preconfigured account codes, dimensional account codes allow you to create unique account codes by segment value at the time trips or other travel documents are created or approved. This eliminates (or reduces) the need to have pre-assigned account codes. Each segment of the code can be entered by the user. The segments and values are validated against financial system configuration and rules. Users can search for segment information by segment value or description, and then select the value they want from the returned list.

Dimensional account codes utilize combinational rule sets that are configured and established via the integration process with E2i. These are useful if your agency cannot provide a full master list of all valid account code strings, or your agency's financial system uses complex business rules that prevent the enumeration of all valid strings.

**NOTE**: Contact your CWTSatoTravel program or implementation manager for more information about implementing dimensional account codes in E2.

# Dimensional Account Code Templates

Dimensional account codes, when utilized by your agency's financial system, typically contain many segments. To facilitate the creation of dimensional account codes, E2 allows you to utilize templates, bypassing the segment-by-segment creation process by pre-populating segments that contain static account code information (i.e., not reference data segments).

A template is any dimensional account code that is already associated with your travel document or that has been added to an accessible Favorites list. The Account Code Selection window automatically creates templates for you from these account codes. Any account code already added to the document (i.e., on the Accounting workflow page) is listed in the Trip Accounting Code Templates section on the **Add Account Codes** tab, while the Favorite Accounting Code Templates section lists all account codes flagged as favorites.

# Direct Billed

"Direct billed" refers to a negotiated agreement with a travel supplier (e.g., lodging provider, airline, car rental agency) who agrees to bill directly to an agency for payment. These expenses will not be claimed for reimbursement on the employee's travel voucher.

# **Disbursements**

Disbursements identify who or what accounts are reimbursed for expenses on a travel voucher (including supplemental vouchers and voucher reclaims) or local travel claim. Payment may be to you (the traveler), a government-issued travel charge card, or agency billed (<u>central billing account or CBA</u>). You specify who is to be reimbursed for travel expenses prior to submitting the voucher or local travel claim for approval.

Agency travel policy controls the selections available to you. If you cannot select the appropriate source to be repaid, contact your travel policy manager for clarification of your agency's reimbursement policy.

- You select disbursement information when you add or update expenses on a voucher or local travel claim.
- The **Pay To** drop-down list is limited to the allowed sources, based on your applicable travel policy settings.

## Document Approver Level

The **Document Approver level** drop-down list (in User Settings) allows an administrator to specify the highest hierarchy level at which you can perform approval functions.

### Document Number

A document number is a number assigned to a specific document (e.g., authorization, advance, voucher, etc.) and used to reference all financial transactions related to that document that are sent to, and received from, your agency's financial system.

#### Format

During your agency's initial configuration, a document number format is created, corresponding to the standards of your agency's financial system. E2 then assigns the format to all travel documents created by agency users, creating unique document numbers.

#### **Automatic and Manual Numbering**

Document numbers may be automatically assigned by E2, or your agency may prefer to have users manually assign document numbers to travel documents. Manual assignment is referred to as the custom document number feature. When enabled, travelers, arrangers, and approvers can assign unique document numbers to new travel documents.

The following rules apply to automatic document numbering:

- The letters in document numbers are upper case.
- A document number may contain segments, which can be used to identify information related to a trip.
- Document numbers have a maximum length of 50 characters (including all segments).
- Non-alphanumeric characters (including spaces) are not included in segments when a document number is created. For example, if a traveler's last name is O'Conner, the value of segment two will be OCO.
- E2 fills any empty spaces of a segment with zeros. For example, if a traveler's last name is Vee and the segment is defined as six characters in length, the document number will contain *VEE000*.

### Example

An agency has specified that travel documents will be assigned a 20-digit document number of six segments with lengths of three, three, four, one, seven, and two characters, respectively. A trip is created that has the following characteristics:

- The traveler's name is Jane Smith.
- Jane Smith's major customer ID is CR.
- Jane Smith created an authorization, which was assigned a trip ID of 456 when it was created.
- The authorization was submitted to an approver on 11/15/2017 (fiscal year 2018).

Based on these criteria, the authorization is assigned the 20-character document number: *CR0SMI2018T000045600*. The following table explains how each segment of the document number was assigned.

Segment	Number of Characters	Description
1	3 (CR0)	The first three characters of the major customer ID. Zeros were used to fill in the empty characters of the segment.
2	3 (SMI)	The first three letters of the traveler's last name.
3	4 (2018)	The fiscal year in which the trip was submitted.
4	1 (T)	The document type ( $T =$ travel authorization).
5	7 (0000456)	The trip ID. Zeros were used to fill in the empty characters of the segment.
6	2 (00)	<ul> <li>The sequence number for the document number suffix.</li> <li>Hypothetical suffix designations that might be assigned by an agency include: <ul> <li>00 – new travel authorization</li> <li>01 – amended travel authorization</li> <li>02 – pre-trip voucher</li> <li>03 – incremental voucher</li> <li>04 – reclaim voucher</li> <li>05 – final voucher</li> <li>06 – supplemental voucher</li> </ul> </li> </ul>

## **Document Recall**

You cannot make changes to a document that is pending approval. The recall feature, however, allows a traveler or arranger to remove a document pending approval from the approval queue and return it to its previous status so it can be modified. This action:

- Removes the document from the approval process
- Notifies the assigned approver or pool of approvers
- Makes the document available to the traveler or arranger for changes
- Returns the document to its previous status

#### Process

Complete the following steps to recall a document.

1. Access the document's Summary page.

**EXAMPLE**: Locate a local travel claim on the My E2 **Local Travel** tab, and then click the **Show** link. If you go to a document dashboard, locate the document on the dashboard, and then click the **Show** link to display the document's Summary page.

2. Click **Recall** (at the bottom of the page).

#### **Recall Button**

If the **Recall** button is not available, check the status of your document. Your document must have a status of *Pending Approval* for the **Recall** button to display. You cannot recall a document with a status of *Pending Audit* or *Pending Approval* (*Rejected by Agency*). Travelers can make changes to a local travel claim or voucher with a status of *Pending Traveler Review* by clicking the **Modify** button, which displays in place of the **Recall** button.

### **Document Retention**

All trips stay in your permanent record for six years and three months. Along with normally closed trips, this includes:

- Amended trips
- Revoked authorizations
- Canceled authorizations

#### **Document Removal Process**

E2 allows searchable access to indexed and archived travel transaction information (including receipts attached to authorizations and vouchers) for six years and three months (75 months) from the date of the paid voucher. After the 75-month retention period, E2 systematically purges document information based on selection criteria:

- Trips and local travel claims are candidates for purging 75 months after the final voucher is closed and the trip is closed.
- Open authorizations and group authorizations are candidates for purging once all referencing trips are purged.
- Documents that have not been submitted for approval are purged 75 months after the document creation date.
- Documents that are pending approval are not purged regardless of age.

#### Schedule for Document Removal

A scheduled weekly process will execute document removal and maintain a history of actions. The document removal schedule was enabled Saturday, March 25, 2017 (i.e., two weeks after the 17.1 production release), and is scheduled to run once per week on Saturday evenings.

## **Document Revision**

"Document revision" refer to the ability of an approver to return a document pending approval to a traveler or prior approval level (based on your agency's settings) for revision. This action requires the approver to select a reason for returning the document and to add comments. The document's status changes to *Revised*, and the traveler or prior approver can make changes and resubmit the revised document for approval.

## **Document Status**

The status of your travel document determines where your document is within the approval process. It also determines what you will be able to do with your travel document, or with other documents associated with your trip. The document's status displays in the header on each workflow page, as well as in the lists on the My E2 **Trips**, **Local Travel**, **Open Authorization**, and **Group Authorization** tabs.

The following tables list the possible statuses for each document type in E2.

#### Advance

Status	Description	Allowed Actions
Amended	The approved advance has been changed.	No actions available.
Awaiting Payment	The advance has been approved and is pending payment.	No actions available.
Canceled	The advance has been canceled.	No actions available.

## Domestic Partner

A domestic partnership is two individuals who are each other's sole domestic partner and remain so indefinitely. These individuals are willing to promptly disclose, if required, any dissolution or change in the status of the partnership and would marry, but for the failure of their state or other jurisdiction of residence to permit same-sex marriage.

See Spouse.

## E2 User ID

Also known as "user name" or "login name."

An E2 user ID is a unique identification value assigned to a user when that user's record is created in E2. When you log on to E2, you enter your E2 user ID and password.

## **Electronic Funds Transfer**

Electronic Funds Transfer (EFT) refers to the process by which funds are electronically transferred from one account to another account without manual intervention.

## Email Notifications

Many actions taken in E2 result in notifications to interested parties via email. For example, approval of a document results in an email notification. The recall of a document triggers an email to the assigned approver or group of approvers. Changing a password in E2 sends an email notification to the user.

Some email notifications are optional; a user can "unsubscribe" to an optional email notification, after initial receipt of that type of notification, in their profile. Click the **Edit Email Notifications** link in the Other Features section of the profile.

## Essential Unit Messing

**NOTE**: Essential Unit Messing, or EUM, is a JTR-only travel policy item.

Essential unit messing (EUM) refers to the use of a government dining facility by a unit or a group (e.g., organizational unit, operational element, operational deployment, detachment) when it has been determined it is necessary for accomplishing training and readiness or military operations.

### EUM Reimbursement Type

When EUM has been established, the government provides meals to a service member and M&IE should be reduced to only the applicable incidental expenses. You can select the *EUM* option from the **Reimbursement Type** drop-down list in the authorization's Meals and Incidental Expenses window for each day for which essential unit messing is applicable. When selected, the **M&IE Amount** field defaults to the local incidental per diem rate for the specific date, and the **Breakfast Provided**, Lunch Provided, and Dinner Provided check boxes are checked, but remain enabled.

If one or more of the **Provided** check boxes is cleared, the **M&IE Amount** field on the authorization defaults to the <u>proportional meal rate (PMR)</u> plus the local incidental per diem rate for the specific date, using current PMR calculations. You will need to itemize the "unprovided" meal expense on the voucher to be reimbursed.

# Expense Type

An expense type is a name for a category of travel expenses, such as lodging, airfare, subway fares, laundry, and tips. Each workgroup selects individual expense types to make available to travelers, and can customize the expense type name. For example, to cover the category of rental car expenses, your workgroup may have an expense type of *Rental Car*, while another workgroup may have an expense type of *Hired Car* or *Rented Auto*.

**NOTE**: If you have a travel expense but are unsure of the expense type to select, contact your E2 administrator or travel policy manager for assistance.

### Expense Groups

Expenses are also summarized by group. Expense groups include:

- Lodging expenses
- Meals and incidental expenses
- Other expenses

**NOTE**: "Other" expenses include transportation (e.g., airfare, rail, rental car) and all expenses not considered lodging or M&IE (e.g., fuel, subway fares, laundry, tips).

# Favorites List

E2 provides a Favorites List feature to make account code selection easier and save you the hassle of searching for specific account codes every time you want to use them. If your travel policy supports this feature, account codes can be saved as favorites with meaningful names. These favorites are then available from the Accounting workflow step for all travel documents.

Standard account codes may be added as favorites from your user profile or while you are assigning accounting to a travel document. If allowed, you can also choose to share your favorites with other users in your office or workgroup. (In some cases, travel policy managers maintain "favorites" lists and make them available to users.)

**TIP**: If your agency uses dimensional account codes, you may only update your Favorites list from the Accounting workflow page after the account code has been added.

## Fax Attachment

Receipts or other information may be attached to a document via fax. This feature may not be available to all users, and faxing attachments may result in additional costs to the agency.

# Fax Cover Page

You must print a fax cover page for each fax you submit. The fax cover page includes information that associates the fax with the appropriate travel document:

- Bar code
- Traveler name
- Trip or local travel claim ID
- Date information
- Fax phone number

**TIP**: If the fax cover page does not include a phone number, your group may not support faxed attachments. You should scan and upload your receipts or other attachments. If necessary, contact us for assistance.

#### Process

Complete the following steps to print a fax cover page.

- 1. Open the travel document.
- 2. Click Attachments in the Other Actions section.
- 3. Click the Attach Fax link.
- 4. Click the **Print the Fax Cover Page** link (in step 1 of the Fax Attachment(s) section of the window). The cover page opens in a pop-up browser window.
- 5. Click **Print This Page**, or right-click and select **Print** from the menu. The standard Print dialog box displays.
- 6. Select your printer.
- 7. Click Print, and then click Close.
- 8. Assemble and fax your documents.

# FedRooms Property Indicator

When searching for a hotel using the online booking tool, a check mark in a circle

( FedRooms Property ) indicates the hotel is a FedRooms-preferred property. As the government's preferred hotel program, FedRooms properties and rates should be your first choice when making hotel reservations.

# Fly America Act

The Fly America Act (49 U.S.C. 40118) requires federal employees and their dependents, consultants, contractors, grantees, and others performing United States government-financed foreign air travel to travel by U.S. flag air carriers, unless travel by a foreign air carrier is a matter of necessity, or when U.S. flag air carrier service is not available within the Act's guidelines.

If your reservations violate the Fly America Act, you are prompted to select a reason to justify the out-ofpolicy flight selection.

#### **Exceptions**

The Fly America Act requires the use of U.S. flag air carrier service for all air travel funded by the U.S. government, except as provided in <u>sections 301-10.136 and 301-10.137</u> of the Federal Travel Regulation, or when one of the following exceptions applies.

- Use of a foreign air carrier is determined to be a matter of necessity in accordance with section 301-10.138.
- The transportation is provided under a bilateral or multilateral air transportation agreement to which the United States government and the government of a foreign country are parties, and which the Department of Transportation has determined meets the requirements of the Fly America Act.
  - Information on bilateral or multilateral air transportation agreements impacting United States government-procured transportation can be accessed at: <u>http://www.gsa.gov/openskies</u>.
  - If determined appropriate, GSA may periodically issue FTR Bulletins to provide further guidance on bilateral or multilateral air transportation agreements impacting United States government-procured transportation. These bulletins may be accessed at: <u>http://www.gsa.gov/bulletins</u>.
- You are an officer or employee of the Department of State, United States Information Agency, United States International Development Cooperation Agency, or the Arms Control Disarmament Agency; your travel is paid with funds appropriated to one of these agencies; and your travel is between two places outside the United States.
- No U.S. flag air carrier provides service on a particular leg of the route. In this case, foreign air carrier service may be used, but only to or from the nearest interchange point on a usually traveled route to connect with a U.S. flag air carrier service.
- A U.S. flag air carrier involuntarily reroutes your travel on a foreign air carrier.
- Service on a foreign air carrier would be three hours or less, and use of the U.S. flag air carrier would at least double your en route travel time.
- The costs of transportation are reimbursed in full by a third party, such as a foreign government, international agency, or other organization.

# Funds Balancing

Funds balancing is a running total of an account's available funds. Each trip appropriates money to pay for travel expenses when the voucher is filed. Funds balancing allows you to know how much money is available in a particular account for use on future trips.

# Funds Obligated

By default, funds are obligated after the authorization receives final approval. In some instances, however, the agency's financial system must specifically notify E2 that the authorization is obligated. The obligated balance for each account may appear on the Accounting page for an approved authorization and for each voucher associated with the trip, if your agency's financial system supports this feature. In these cases, you may also see an obligation status appended to the authorization status, such as *Approved – Pending Obligation* or *Approved – Obligation Accepted*, and changes to the obligation status logged in the trip history. Not all agencies that notify E2 of the obligation status, however, are configured to display this information.

#### **Impact of Obligation Status**

You can create a voucher, but you cannot submit it for approval until the authorization is obligated. If you are unable to submit a voucher because your authorization is not obligated, contact your E2 help desk for assistance.

Accounting and funding data, necessary for ticket issuance, is typically sent to the travel management center (TMC) after final authorization approval. In some cases, travel policy requires this data to be sent only after E2 receives notification that the obligation is accepted.

#### **Obligation Information and Errors**

Some agencies require a voucher to match the authorization obligation, while other agencies may allow the voucher to exceed the obligated amount by a certain percentage. To fix obligation errors, amend the authorization to correct the expenses and make account code adjustments. If the changes are within your agency's travel policy, the amended authorization is automatically approved, and you can create and submit the voucher for approval.

- The **Obligated Balance** field is calculated by E2 based on trip activity. This amount can be a negative number, if a voucher allocated more to an account code than is left in the obligation (e.g., actual voucher expenses exceed the estimated expenses for the account code).
- The actual obligation balance that is transmitted to E2 from the agency's financial system on a periodic basis may also display to the left of the obligated balance in the **Agency Balance** field. The values in these two fields may not match.

# <u>GDSx</u>

See Global Distribution System.

## **Global Distribution System**

Global Distribution System (GDS) refers to a reservation system that holds information about individual travel plans. There are multiple reservation systems available globally.

- GDSx is the third-party service E2 uses to communicate with the global reservation systems.
- GDSi is the interface used by E2 to communicate with GDSx.

## Government Administrative Rate Supplement

The Government Administrative Rate Supplement (GARS) is a charge that will be added to any government car rental as per the DTMO agreement (formerly the SDDC agreement) regarding government rental cars.

As established in the DTMO agreement, rental car vendors will charge the renter a standard mandatory government administrative rate supplement (GARS) of \$5.00 per day worldwide.

**NOTE**: GARS is an additional fee that is not included in the rates offered by the travel management center (TMC) or online reservation system. More information can be obtained via the following link: <u>http://www.defensetravel.dod.mil/Docs/CarRentalAgreement.pdf</u>.

### Government Meal Rate

**NOTE**: The Government Meal Rate (GMR) is a JTR-only travel policy item.

The government meal rate (GMR) is a standard rate (that excludes incidental expenses) charged to all officers and enlisted members receiving an allowance for subsistence (other than those charged a <u>discount rate</u>); any officer, enlisted member, or federal civilian employee receiving the subsistence portion of per diem; and all other personnel authorized to eat in Department of Defense dining facilities. The GMR is used to calculate the proportional meal rate (PMR), when necessary.

### **Discount GMR**

A discount rate will be charged to the following:

- Spouses and other dependents of enlisted personnel in pay grades E-1 through E-4
- Members of organized, non-profit youth groups (e.g., Civil Air Patrol, Junior ROTC), sponsored at either the national or local level, and permitted to eat in the general dining facility by the commanding officer of the installation
- Officers, enlisted members, and federal civilian employees who are not receiving the meal portion of per diem and who meet one of the following criteria:
  - Performing duty on a U.S. government vessel
  - o On field duty
  - In a group travel status
  - Included in <u>essential unit messing</u> (as defined in the JTR, Chapter 2, Par.020315)
  - Assigned to essential station messing as an enlisted member (as defined in DoDD 1418.05)
- Officers, enlisted members, and federal employees who are not receiving the meal portion of per diem and who are on a U.S. government aircraft on official duty, either as a passenger or as a crew member engaged in flight operations.
- Officers, enlisted members, and federal employees on Joint Task Force operations other than training at temporary U.S. installations, or using temporary dining facilities

#### **GMR/PMR** Reimbursement Type

You can select the *GMR/PMR* option from the **Reimbursement Type** drop-down list in the authorization's Meals and Incidental Expenses window for each day for which the government meal rate is applicable. When selected, the following changes are made to the corresponding fields in the data grid:

- The **M&IE Amount** field defaults to the government meal rate (GMR) amount plus the local incidental per diem rate for the specific date.
- The **Breakfast Provided**, **Lunch Provided**, and **Dinner Provided** check boxes are checked, but remain enabled.
- The **Notes** field is set to *GMR*.

If one or more of the **Provided** check boxes is cleared, the **M&IE Amount** field defaults to the proportional meal rate (PMR) plus the local incidental per diem rate for the specific date, using current PMR calculations, and the **Notes** field is set to *PMR*.

## Government Transportation

"Government transportation" refers to transportation facilities owned, leased, or chartered and operated by the U.S. government for transportation on land, water, or in the air (e.g., government auto, government plane, aircraft on loan or owned by an aero club, etc.).

### **Govt Auto**

A "govt auto" (i.e., government-furnished automobile or government-furnished vehicle) is an automobile or light truck (including vans and pickup trucks) that meets one of the following criteria:

- Owned by an agency
- Assigned or dispatched to an agency from the GSA Interagency Fleet Management System
- Leased by the government for a period of 60 days or longer from a commercial source (i.e., obtained for short-term use from a commercial firm under the provisions of an appropriate GSA Federal Supply Schedule contract)

#### **Government Bus**

A "government bus" is a bus that is operated for the exclusive use of an executive agency and meets one of the following criteria:

- Bus, which the executive agency owns (i.e., holds the title to) or borrows for any length of time under a bailment or equivalent loan agreement
- Hired commercial bus, which the executive agency:
  - Leases or lease-purchases with the intent to take title
  - o Charters or rents
  - Hires as part of a full-service contract or inter-service support agreement (ISSA)

# Government-Issued Travel Charge Card

Also known as TCC or IBA.

A travel charge card is a government-issued credit card for specific travel uses. Your travel policy controls the use of a government-issued travel charge card for airline ticket purchases and hotel reservation guarantees. You may see both *TCC* (travel charge card) and *IBA* (individually billed account) acronyms used; both refer to the same card.

### E2 User Profile

Travel charge card and personal credit card information is stored in your E2 user profile. To access your profile, select *Profile* from the User Options menu on the E2 task bar.

If you require a travel charge card but do not currently have one, contact your group's travel policy manager for assistance.

# Group Authorization

A group authorization is a request for two or more users to travel to the same destination at the same time. For example, a group authorization could be used when multiple people in the same office or workgroup need to attend a conference. A group authorization must be approved before the travelers can complete their individual travel plans.

# GSA Travel Purpose

Your agency's travel policy determines the options available in the **Type of Travel** drop-down list on the authorization's Basic Information page and (if enabled) the Local Travel Basic Information page. Each travel type, however, must be aligned with a specific GSA travel purpose, and that GSA travel purpose and code may be included as part of the E2 travel type's code or description.

The following table defines each GSA travel code and purpose, as well as explains when any travel type associated with each code should be used. (This information may also be found in <u>Appendix C – to</u> <u>Chapter 301 – Standard Data Elements for Federal Travel</u> of the Federal Travel Regulation.)

**NOTE**: If you remain uncertain of the type of travel you should select, based on your agency's unique travel type codes and descriptions, contact your travel policy manager or system administrator for further assistance.

Travel Purpose Identifier	Definition
P1 – Employee Emergency	Select this option for any travel related to an unexpected occurrence/event or injury/illness that personally and directly affects the employee and that requires immediate action/attention.
	<ul> <li>Examples</li> <li>Traveler is incapacitated by illness or injury, or the death or serious illness of a family member</li> <li>A catastrophic occurrence or impending disaster directly affects the employee's home</li> <li>Travel for medical care while the employee is TDY away from the office station</li> <li>Death of an employee/immediate family member when performing official duties away from the official travel station or home of record</li> <li>Medical attendant transportation</li> <li>Assistance travel for an employee with special needs</li> <li>Travel for threatened law enforcement/investigative employees</li> </ul>

# Held Reservation/Held Reservations List

If you purchase travel prior to creating an authorization, the reservation is held until you associate it with an authorization. The Held Reservations list allows you to view and manage reservations that are not yet associated with an authorization.

### Warnings/Duplicate Bookings

After logging on, a warning message displays on your landing page if you have a reservation in your Held Reservations list (e.g., *You have held reservations. Click Show Held Reservations on the My E2 Trips tab for details.*). To avoid potential duplicate bookings, E2 also displays the Held Reservations window for your review before you go to the online booking tool to make new reservations, either via the **Start a Travel Document** drop-down list or through the authorization's Reservation step.

**TIP**: It is your responsibility to manage your held reservations, and cancel reservations when necessary, to avoid penalty fees or other charges.

### Access the Held Reservations Window

To view your held reservations, select *Show Held Reservations* from the **Start a Travel Document** list on the My E2 **At a Glance** tab, or click **Show Held Reservations** on the My E2 **Trips** tab. When the Held Reservations window displays, select from the following options:

• Click in the **Select** check box of each reservation you want to associate with a trip, and then click the **Create an Authorization** button to create an authorization with the selected reservation(s).

- Click the **Show** link to display the Itinerary window, which allows you to review the itinerary details of the corresponding reservation.
- Click **Change** to access the E2 online booking tool and make changes to the reservation, such as add a component, modify a seat selection, or change a flight segment.

**TIP**: The **Change** link is only available if you originally made your reservation online. You cannot, however, make changes to a rail reservation, even if it was made online. To change a rail reservation, contact your travel management center (TMC).

- Click **Cancel** to completely cancel the corresponding reservation.
- Click Exit Window to close the window without taking any action.

## **Hierarchy**

All users in your agency are associated with an organizational structure. The hierarchy starts with the agency and is segmented into smaller groups.

- Agency
- Organization
- Major Customer
- Minor Customer

# Home Site

Your "home site" is your default departure point and final arrival site for trips created in E2 (i.e., the location from which you typically depart for work-related trips). Your default home site information is part of your profile.

**NOTE**: Depending on travel policy, you can change your default departure or final arrival sites on an authorization. This changes site information **for that trip only**; the default home site information defined in your user profile remains unchanged.

## IA Mileage

IA mileage refers to "in-and-around mileage." This is the mileage that accumulates when you use your personal vehicle in and around your permanent duty station (i.e., home location/home site) or as a mode of transportation for a trip. IA mileage is now more commonly referred to as "POV mileage."

**TIP**: Click the **Privately Owned Vehicle (POV) Mileage Reimbursement Rates (GSA)** link on the **Agency Links** tab in the Message Center to view current mileage rates on the <u>GSA website</u>.

### Incremental Voucher

See Voucher Type.

## Individual Billed Account

See Government-Issued Travel Charge Card.

## Invitational Traveler

An invitational traveler is a traveler who meets either of the following criteria. Invitational travel is defined in Title 5, Section 5703 of the United States Code.

- Employed intermittently in a government service as a consultant or expert (appointed under an expert or consultant statute), and paid on a daily "when-actually-employed" basis.
- Serving without pay, or at a rate of exactly \$1 a year, when acting in a capacity that is directly related to, or in connection with, official activities of the government.

### Actions

An invitational traveler may:

- Create authorizations and complete travel.
- Claim travel or transportation expenses while away from home or their regular place of business and at the place of employment or service, based on standard TDY rates.
- Use the contract City Pair program when booking air travel.

#### Examples

Examples of invitational travelers include:

- The recipient of a personal services contract for a determined period of time with expectations that travel will be required.
- A person who is invited to deliver a speech or provide training, and is provided an honorarium or fee for the service.

## Laundry Expenses

To qualify for reimbursement of laundry expenses:

- Your trip must be CONUS travel.
- The duration of your trip must be four consecutive nights or more.

**NOTE**: For additional details regarding laundry expenses, contact your travel policy manager, consult your agency's travel policies, or view information in the <u>FTR</u>.

### Leave

Also known as "official day off."

Leave refers to a personal break in official duty while at a temporary duty (TDY) station. Leave days are normal workdays (i.e., non-holiday, non-vacation) during a trip that should not be considered workdays.

### Add Official Leave/Day Off

If you are not working on a normal workday, you should mark that day as an official day off. Click the **Add Official Leave** link in the Other Actions section on the Site Details step of an authorization's workflow to display the Official Leave window.

You can also mark a day as an official day off if you select the **Day Off** check boxes for lodging and meals and incidental expenses on the Expenses workflow step.

## Limited Open Authorization

A limited open authorization is a blanket authorization created for a particular period of time with specific restrictions (e.g., dollar amount, limited sites, etc.).

After a limited open authorization is approved, any travel requests scheduled under the limited open authorization will not require additional approvals, unless the travel request exceeds the required restrictions (e.g., estimated trip costs or total estimated OA expenses).

## Liquidation

Liquidation refers to the process of repaying a travel advance from trip expenses that are reimbursed to the traveler during the voucher process. You can liquidate all or part of the travel advance on any non-final voucher for the trip. All outstanding advance amounts, however, must be liquidated on the final voucher for a trip, if possible.

Each time you create and submit a voucher, E2 automatically calculates the advance amount that has not yet been liquidated (**Advance Amount Outstanding** field), as well as the total "pay to traveler" expenses that can be used to liquidate the advance (**Pay To Traveler Expenses** field).

**NOTE**: If retained advances are enabled, E2 also calculates the total amount of retained advances in the **Retained Advance Amount** field.

### **Rules for Advance Liquidations**

The following rules apply to advance liquidations.

- The total amount of each approved advance must be liquidated, regardless of the amount that was actually disbursed to you as a traveler.
- If the voucher is NOT a final voucher, you must enter the advance amount to liquidate. The maximum amount to liquidate is the lesser of the Advance Amount Outstanding and the Pay to Traveler Expenses fields. You can, however, liquidate a smaller amount, if necessary. If retained advances are enabled, the value in the Retained Advance Amount field is added to that in the Advance Amount Outstanding field to calculate the comparison amount.
- For a final or supplemental voucher, E2 applies the maximum amount available to liquidate the advance and does not allow any changes. If you are allowed to retain advances, however, E2 calculates the maximum amount available to liquidate, but requires you to enter the liquidation amount. You must liquidate the lesser of the **Advance Amount Outstanding** and the **Pay to Traveler Expenses** fields. If you have a sufficient amount in the **Pay to Traveler Expenses** field, you can liquidate up to the total of the **Advance Amount Outstanding** and **Retained Advance Amount** fields.

# Local Travel Claim

A local travel claim is a voucher for travel within the vicinity of an employee's designated official permanent duty station (PDS). Typically, travel is considered *local* if it is within a 50-mile radius of your PDS. A local travel claim allows you to claim items associated with the local travel, such as taxi fares, tolls, tips, parking, and privately owned vehicle (POV) mileage.

- Miscellaneous expenses incurred while performing official business not in conjunction with temporary duty (TDY) travel can also be claimed using the local travel claim document.
- Per GSA policy, you are not eligible to claim lodging when submitting a local travel claim.

**TIP**: Travel policies differ. If you are unsure of when to file a local travel claim, or what expenses can be claimed, contact your travel policy manager for assistance.

# Lodging and M&IE Calculations for One-Day Trip

No lodging expenses are allowed on a one-day trip.

If the trip duration is greater than 12 hours but less than 24 hours, the rate of reimbursement is 75% of the M&IE rate. The **M&IE Amount** field in the Meals and Incidental Expenses window will display the adjusted M&IE amount for the trip.

# Lodging Per Diem Rate

Lodging per diem rates are based on your *per diem* location, not the hotel location. (The per diem location is the "Going To" site on the authorization's Site Details page.) Daily lodging and M&IE rates are shown in the auto-complete list when you are selecting sites from the **Going To** field on the Site Details page.

- If may be necessary to find a hotel closer to your per diem site and in the same county or city.
- If no alternate hotels with the appropriate per diem rate can be found, contact your supervisor for assistance. You may be instructed to select an "actual" reimbursement type for lodging, and include remarks to help your approver understand why you made the selection.

### **GSA Per Diem Rates**

Domestic per diem rates for federal travelers are available on the <u>GSA Per Diem Rates web</u> <u>page</u>, which also includes links to per diem rates for Alaska, Hawaii, U.S. territories and possessions (from the Department of Defense web site), and foreign sites (from the Department of State web site). This, and other helpful links, can be found on the **Agency Links** tab in the E2 Message Center.

# Lodging Tax

Lodging tax refers to taxes charged on lodging. Lodging tax is a separate expense item that is entered in the Lodging Expenses window. (Go to the Expenses step of an authorization or voucher, locate the Lodging expense on the list, and click the **Modify** link.)

Lodging tax:

- Is authorized for reimbursement for <u>CONUS travel only</u>. Lodging taxes are considered a separate expense and are **NOT** included in the lodging rates for sites within the continental U.S. (i.e., CONUS sites), as well as U.S. areas outside the continental U.S. (e.g., Alaska, Hawaii, Guam, and other non-foreign OCONUS locations). You must claim lodging taxes separately.
- Is not an allowed expense for international travel. An international trip is considered to be OCONUS lodging, and lodging tax is not a separate expense. (Per diem lodging rates for foreign sites include lodging taxes.)

### **Reimbursable Amount**

The reimbursable amount of lodging tax for CONUS sites and U.S. areas outside the continental U.S. (i.e., non-foreign OCONUS sites) is based on the site's per diem rate. For example:

- If the reimbursement type is *Per Diem*, you can be reimbursed for all lodging taxes. If you choose lodging that exceeds the lodging per diem rate, you will not be reimbursed for taxes on the amount that exceeds the lodging per diem rate.
- If the reimbursement type is *Reduced* (i.e., a reduced per diem rate), you can be reimbursed for all lodging taxes since the expense is below the per diem rate.

• If the reimbursement type is *Actual*, you can be reimbursed for the actual cost of lodging. For example, if a site has a lodging per diem rate of \$89, and you choose lodging with a rate of \$110, you can be reimbursed taxes for the entire amount of \$110

Refer to section <u>\$301-11.27</u> of the FTR for more information about per diem rates and lodging taxes. Support for separate reimbursement of foreign lodging taxes differs by agency. Review your agency's travel policies or contact the appropriate agency personnel for clarification and assistance.

**NOTE**: For historical purposes, if the reimbursement type was Conference, you could have been reimbursed for all lodging taxes up to an amount of 125% of the lodging per diem rate. The Conference reimbursement type was removed from the FTR in January 2014, and from E2 with release 14.2.

# Long Term Taxable Travel (LTTT)

With long-term taxable travel (LTTT), E2 Solutions will calculate and store the appropriate employer and employee withholdings (e.g., employer FICA, Medicare) and the withholding tax allowance (WTA). If the feature is enabled, a trip is considered long-term taxable travel when the following conditions are met:

• The traveler is traveling under Federal Travel Regulations (FTR).

**NOTE**: No taxes will be calculated if the traveler is traveling under Joint Travel Regulations (JTR).

- The travel type selected for the trip allows tax calculations.
- The trip is greater than 365 days (i.e., the trip end date minus the start date, plus one day).

### Lowest Compact Car

Lowest Compact Car (LCC) refers to the lowest compact car available to the traveler at the time travel was booked. LCC is stored in the reservation passenger name record (PNR) during online booking. The fare is included, along with the booked rental car fare, in the trip's Travel Policy Warnings.

### **Travel Policy Justification**

Whether an explanation is required for the use/non-use of the lowest compact car (when the selected rental car type is within agency policy) is determined at the major customer level.

#### Require Lowest Compact Car Justifications = Yes

When the **Require Lowest Compact Car Justifications** rental car policy item is set to Yes, if the car type is in policy (e.g., Compact), you are required to select one of the following options from the **Explanation** drop-down list in the Travel Policy Justifications section of the authorization's Travel Policy workflow step:

- Car within Policy (CE0)
- Other than least expensive compact for agency mission (CE8)

If the car type is out of policy, select one of the following options from the **Explanation** drop-down list:

- Medical disability or other special need (CE1)
- Agency Mission (CE2)
- Cost is less than or equal to in policy car (CE3)
- Multiple employees (CE4)
- Large amount of Government material (CE5)
- Safety (sever weather, rough terrain) (CE6)
- No Compact car available (CE7)

#### Require Lowest Compact Car Justifications = No

When the **Require Lowest Compact Car Justifications** rental car policy item is set to *No*, you are not required or asked to provide any justification for an in-policy car. You are, however, required to select an option from the **Explanation** drop-down list (from the options listed above) for any vehicle that is out of policy.

# Lowest Logical Airfare

Lowest logical airfare (LLA) is the lowest airfare available to a traveler at the time travel was booked, based on the following criteria:

• LLA is based on the traveler's search options.

**NOTE**: Only segments returned in the "low fare" online booking search results are considered for LLA; alternate airports are only included if they are part of the criteria for the search.

- LLA is typically within six hours (+/-) of the fare that was selected for each segment.
- Preference is given to contracted fares.

After a traveler completes outbound and inbound flight selections online, they are directed to a Review Low Fare Options page. If the default sort option was "price," or if the traveler selects "price" as the sort option for the list, the LLA is the total cost of the first option shown on the page. (If the traveler is not directed to this page, no lower airfare exists; the traveler has chosen the LLA.)

LLA is stored in the reservation passenger name record (PNR) during online booking, and is also stored when agent assistance is required with the booking. It displays on the authorization's Travel Policy page in the Travel Policy Warnings section. If LLA is not found in the PNR (or if there is no PNR associated with the authorization), the **LLA** field on the Travel Policy page displays *Not Available*. Like the **Booked Airfare** field shown in the same Travel Policy Warnings section, LLA is the total fare, including applicable taxes.

# Major Customer

A major customer is part of the E2 customer hierarchy. The major customer is a larger group served by the organization, and can be used to define the region of an agency.

For example, the Department of Interior is an agency that includes the Bureau of Land Management and National Parks Service as organizations. Major customers are larger groups that the organization serves, such as state governments, contractors and vendors, and non-profit organizations.

## Make Reservations

A feature that allows a traveler to shop for (and book) flights or rail, hotel accommodations, and car rentals online before creating a travel authorization. This feature is enabled at the agency level, along with online booking capabilities through the E2 online booking tool.

### Held Reservations

If you purchase travel prior to creating an authorization, the reservation is placed in your Held Reservations list until you associate it with an authorization. You can also change or cancel the reservation from the Held Reservations list.

After you log on, a warning message displays on your landing page if you have a reservation in your held reservations list.

### Get Started

Select one of the following options to get started:

- Select *Make Reservations* from the **Start a Travel Document** drop-down list on the My E2 **At a Glance** tab, and then click **Go**
- Click Make Reservations on the My E2 Trips tab
- Click the **Make Reservation** link on the authorization's Reservation step
- Click **Create Reservation** in the Reservations section of the Trip Dashboard (available if your travel policy allows reservations to be created after an authorization is approved)

## Meals and Incidental Expenses

Meals and incidental expenses (M&IE) refer to the portion of per diem expenses that relate to meals and incidentals.

## Method of Reimbursement

Method of reimbursement (MOR) refers to the "pay to" selection for an expense (i.e., the entity that will be reimbursed for the expense, such as the traveler or a centrally billed account).

## Minor Customer

Agencies define the lower hierarchical structures, such as minor customers, so specific definitions may vary by agency. In general, a minor customer is usually a sub-agency, and is often referred to in E2 documentation as your office or workgroup.

For example, the Department of Interior is an agency that includes the Bureau of Land Management and National Parks Service as organizations. Major customers are larger groups that the organization serves,

such as state governments, contractors and vendors, and non-profit organizations. Minor customers are smaller groups within each major customer, such as a specific state legislature, forestry commission, or bureau of tourism and travel.

### Non Federal Sponsor

A non-federal sponsor is a source of funds for travel expenses (direct or "in kind"). For example, a non-federal source of travel might be the sponsor of an event at which a government traveler is speaking.

## Non-Federally Sponsored Travel

Non-federally sponsored (NFS) travel is travel that includes expenses reimbursed from a non-federal source of funds (i.e., non-federal sponsor), either directly or in-kind.

### Sponsored vs. In-Kind Expenses

In the Add a Non-Federal Sponsor for This Trip and Modify a Non-Federal Sponsor for This Trip windows, E2 automatically categorizes the authorization's estimated expenses based on expense group information for your agency. You can enter the sponsored and in-kind amounts for each expense category.

Sponsored expenses are those for which the traveler's agency will be reimbursed separately by the sponsor. These expenses are out-of-pocket expenses for the trip, and, as such, the process to claim reimbursement for these expenses occurs outside of E2. Sponsored amounts, however, cannot exceed the total estimated expenses for the category or for the authorization. For example, if you enter *500* in the **Sponsored Total** field for the Transportation expense category, but the estimated total for that category is only \$400, when you click the **Save and Close** button, an error message will prevent you from continuing.

In-kind expenses reflect the value of goods or services received from the non-federal sponsor in relation to the trip. For example, if the non-federal sponsor gives the traveler an airline ticket for travel, the ticket is considered an "in-kind" expense.

- In-kind expenses do not require obligation or reimbursement to the traveler or the agency, but they must be documented for reporting purposes. As they do not impact the expense or line of accounting totals on the authorization, there are no limits placed upon the values entered in the **In-kind Total** field.
- In-kind expenses should <u>not</u> be included as estimated expenses on the authorization. Let's say, for example, a sponsor is providing group transportation to/from a location and the cost is estimated to be \$50. The amount/expense should not be added as an estimated expense on the authorization's Expenses step. Instead, \$50.00 can be entered in the **In-kind Total** field for the Transportation expense category, and any related information or documentation supporting the in-kind expense can be included via remarks or attachments.

#### Add Non-Federal Sponsor

To document NFS expenses, click the **Add Non-Federal Sponsor** link in the Other Actions section of any page in an authorization's workflow. Select this link, after you have added estimated expenses to the authorization, to indicate which expenses are funded or supplied inkind by the non-federal source. Your agency must make the non-federal source of funds available for selection. **TIP**: If you create an authorization, or open an existing authorization, and the **Add Non-Federal Sponsor** link is not available to you, contact your travel policy manager for assistance.

# **Occasional Meals**

**NOTE**: Occasional Meals is a JTR-only travel policy item.

Occasional meals are itemized expenses for breakfast, lunch, and dinner that cannot exceed the <u>proportional meal rate (PMR)</u> for the date. Occasional meals may be authorized or approved when a traveler must either purchase meals from commercial or non-appropriated funds (NAF) sources, or when per diem is not otherwise authorized.

### **Occasional Meals Reimbursement Type**

You can select the *Occasional Meals* option from the **Reimbursement Type** drop-down list in the authorization's Meals and Incidental Expenses window for each day for which that option is applicable. When selected, the following changes are made to the corresponding fields in the data grid.

- The permitted reimbursement is automatically calculated by E2, based on the appropriate proportional meal rate (PMR) value for the travel site, and displayed in the **M&IE Amount** field.
- The **Breakfast Provided**, Lunch Provided, and **Dinner Provided** check boxes are cleared and disabled.
- The **No Incidentals** check box is checked and disabled.

When creating the voucher, the Edit Actual Meals and Incidentals/Occasional Meals window allows you to specify the itemized meal values for breakfast, lunch, and/or dinner. (Incidental expenses cannot be itemized for occasional meals.)

# <u>OCONUS</u>

"OCONUS" is a designation for travel occurring outside the continental United States. The Department of Defense Per Diem, Travel and Transportation Allowance Committee establishes per diem rates for overseas U.S. areas (e.g., Alaska, Hawaii, Guam, and other non-foreign locations), while the Secretary of State (U.S. Department of State) establishes per diem rates for foreign countries.

*TIP*: You can search for and view current per diem rates through the **Agency Links** tab in the E2 Message Center. Select Message Center from the User Options menu on the task bar, click the **Agency Links** tab, and then select the link for <u>GSA per diem rates</u>.

# <u>Official Day Off</u>

See <u>Leave</u>.

# **Online Booking Charge Card Defaults**

A traveler who can make reservations online, and who can add or delete credit card information in their profile, can configure the default charge card to use for airline, rail, and hotel bookings. Options vary based on agency travel policy but may include *Centrally Billed Account (CBA)* or *Travel Charge Card (TCC)*.

# **Online Booking Tool**

The online booking tool (OBT) is the third-party tool that allows users direct access to airline, rail, hotel, and car reservations from within E2.

## **Open Authorization**

An open authorization, also known as an OA or "blanket travel," is a continuing travel authorization issued to a traveler who regularly and frequently makes trips within certain geographical limits over a specified period of time in the performance of assigned duties.

### **Blanket Authorization**

A blanket authorization includes both unlimited and limited open travel authorizations, as defined in the <u>FTR</u>.

### **Travel Requests**

You can create an OA for future travel requests for up to one fiscal year. Your OA may be limited to specific travel locations, dates of travel, and expense amounts. After the open authorization has been approved, you create requests to travel (i.e., authorizations) under the open authorization. As long as the individual travel request conforms to all properties and limitations of the open authorization, it automatically inherits the approval status of the open authorization and does not require additional approval steps. (If the individual trip request exceeds the OA limitations, it can be routed for approval based on your agency's settings.) After travel is complete, you submit reimbursement requests (i.e., vouchers) for the trip created under the OA.

- The period for OAs cannot exceed 365 days. The effective dates of travel (i.e., the start and end dates) for individual trips associated with the open authorization are specified when you create each individual trip request.
- You can cancel an open authorization if no trips have been created under it.
- You can close an open authorization to prevent any future trips from being created under it.

### Outside Advance

An outside advance is an advance that was requested and received outside of the E2 system but will be liquidated against a trip in E2 (i.e., repaid from expenses that would otherwise be reimbursed to the traveler).

### **Overdue Advance**

A travel advance is considered overdue when all of the following conditions are met:

- The ending date for the trip is at least seven days in the past.
- The travel advance has a status of Closed (i.e., it has been paid to the traveler).
- There is an outstanding advance balance (i.e., the paid advance amount is greater than the total liquidation amount for the advance).
- The outstanding balance has not been marked as repaid outside of E2.

**TIP**: Contact your financial department for further assistance with an overdue travel advance.

### **Email Notification**

By default, E2 sends the traveler email notification of overdue travel advances on the following schedule. (Your workgroup or agency may change the schedule for overdue advance notifications, and may make receipt of the emails optional.)

- The first day the advance is considered overdue (ending trip date is seven days in the past)
- 31<sup>st</sup> day
- Every 30 days thereafter, until the advance is marked as reimbursed

**NOTE**: If you pay a travel advance that appears overdue in E2 outside of the E2 application (e.g., you pay your finance office or post directly), an E2 administrator must take action to make the overdue advance as paid. If you pay an overdue advance in this manner and you continue to see an overdue advance reminder for that trip, contact an E2 administrator for assistance.

### Additional Notices

When you have one or more overdue advances, the total amount outstanding displays in the Additional Notices section of the Notifications panel on the My E2 At a Glance tab. Click the see details link to view detailed information.

# <u>PARC</u>

# <u>Pay To</u>

See Method of Reimbursement.

## Payment Account

A payment account is the account that will receive "pay to traveler" expense reimbursement. Your agency is responsible for updating your payment and bank information, and is also responsible for reimbursing your expenses.

**NOTE**: For security reasons, we ask that you contact your financial department for assistance or questions regarding payment accounts.

### Profile

If travel policy permits, payment information is located in your E2 user profile. Select *Profile* from the User Options menu in the task bar (i.e., your name), and then look for the Payment Information section on the User Profile page.

# <u>Per Diem</u>

Per diem (also referred to as a subsistence allowance) is a daily payment, up to a specific limit, used to reimburse a traveler's lodging, meals, and related incidental expenses (M&IE) on a specific day at a specific site, based on established per diem rate tables. The per diem allowance is separate from transportation expenses and other miscellaneous expenses.

Per the <u>FTR</u>:

"The per diem allowance covers the following:

- 1. *Lodging*. Includes expenses, except lodging taxes in the United States, for overnight sleeping facilities, baths, personal use of the room during daytime, telephone access fee, and service charges for fans, air conditioners, heaters and fires furnished in the room when such charges are not included in the room rate.
- 2. *Meals*. Expenses for breakfast, lunch, dinner and related tips and taxes (specifically excluded are alcoholic beverage and entertainment expenses, and any expenses incurred for other persons).
- 3. *Incidental expenses*. Fees and tips given to porters, baggage carriers, hotel staff, and staff on ships."

**TIP**: Refer to <u>Section 301-11 (Subpart A General Rules</u>) of the FTR for complete details. You can also find more information about per diem rates and the controlling entities at the <u>Defense Travel Management</u> <u>Office</u>. If you cannot locate your specific site, you may be directed to a standard per diem rate for the area.

### Per Diem Rates

Domestic per diem rates for federal travelers are available on the <u>GSA Per Diem Rates web</u> <u>page</u>, which also includes links to per diem rates for Alaska, Hawaii, U.S. territories and possessions (from the Department of Defense website), and foreign sites (from the Department of State website). This link and links to other helpful travel information can be found on the **Agency Links** tab in the E2 Message Center.

**NOTE**: Workgroups can configure variable per diem rates for standard sites based on length of travel, or type of travel and length of that travel. If your trip is subject to variable per diem rates, the Notes column on the Lodging Expenses, Meals and Incidental Expenses, and View Daily Expenses windows includes the keyword Variable followed by the percentage of the standard per diem rate applied to the day.

# Per Diem Calculations for First and Last Days of Travel

Per diem is 75% of the meals and incidental expenses (M&IE) rate for the day of departure and the day of return. If prepaid meals are involved, per diem is 75% of the M&IE rate, minus the prepaid meals deductions (not to exceed the amount allowed for incidental expenses).

**TIP**: Refer to <u>section 301-11.18</u> of the FTR for complete details.

# <u>PNR</u>

"PNR" is an acronym for passenger name record, which is a file on a global distribution system (GDS or "reservation system") that contains traveler information, such as itinerary, air/rail, hotel, and rental car information.

The six-character confirmation number shown on your reservation is also known as the PNR. The confirmation code displays in the Reservations section on the **Trip Dashboard** tab, within the Reservations step of the authorization workflow, and in the Itinerary window. The confirmation number applies to the entire reservation. It also appears in the email confirmation of the reservation sent to you by your travel management center (TMC). (The confirmation number may be listed as the "location code" in email confirmations.)

**TIP**: Do not confuse the confirmation number with the airline record locator number, which applies only to a specific airline segment within a reservation.

# Point of Contact

The point of contact (POC) is the person within your hierarchy who is the primary contact. Travelers can direct questions concerning login or password issues to their hierarchy password point of contact via the **Login Help** link on the E2 home page.

# Post-Approval Reservation Creation

Post-Approval Reservation Creation (PARC) allows you to estimate expenses for a trip and make reservations after the trip request is approved.

NOTE: This feature is controlled by your agency's travel policy and may not be available to all travelers.

# Pre-Trip Voucher

See <u>Voucher Type</u>.

## Prepaid Meals

"Prepaid" meals (also known as "meals provided") refers to meals furnished at nominal or no cost by the government or are included in a registration or conference fee. Refer to <u>section 301-11.18</u> of the Federal Travel Regulations (FTR) for complete details.

### **Modify Meals Provided Selections**

Complete the following steps to change your "meals provided" selections on a voucher.

- 1. Access the Voucher Expenses step.
- 2. Click the **Modify** link for the Meals and Incidentals expense. This displays the Meals and Incidental Expenses window. Individual meal check boxes are available for each day.
- 3. If the voucher is part of a multi-site trip, be sure you are reviewing the days for the appropriate site. If necessary, select the correct site from the **Site** drop-down list.
- Select a check box (i.e., Breakfast Provided, Lunch Provided, and/or Dinner Provided) for a particular day to indicate that meal was provided, or clear the check box if the meal was not provided.

**NOTE**: Your workgroup may enable variable per diem rates for standard sites. Those variable rates are a percentage of the standard per diem rate and may differ from the default calculations. If variable per diem rates apply to your trip, prepaid meals are not an allowed option.

5. Save your changes before viewing meal expenses for another site on the trip.

### Per Diem Calculations

By default, per diem is calculated at 75% of the M&IE for the day of departure and the day of return. If prepaid meals are involved, per diem is 75% of the M&IE rates <u>minus</u> the prepaid meal deductions (not to exceed the amount allowed for incidental expenses).

### Primary Approver

A primary approver is the E2 user that is automatically selected to approve a travel document. The travel document is automatically locked to this approver, and is unavailable for approval by alternate approvers unless the document is unlocked.

### **Routing Pools**

A primary approver can be specified in a routing pool but is not required within a routing pool. If a primary approver is not specified in a routing pool, all approvers in that pool will be eligible to approve a travel document that is routed to the pool for approval. The travel document remains unlocked until an approver from the pool locks it for approval activities. When the document is locked by an approver, it is no longer available to other routing pool members for any actions.

## Printable Document

A printable document is available for authorizations, vouchers, travel advances, local travel claims, group and open authorizations. You can view and print two types of printable documents: on-demand and system-generated "Financial System Transaction File."

#### **On-Demand Document**

To create an "on demand" printable that includes the most current document information, open the document you want to print, and then click the **Printable...** link in the Other Actions section. (Be sure you are viewing the document and not the dashboard.)

- For an authorization, the **Printable...** link is not available until the Site Details step is complete. For all other documents, the **Printable...** link is not available until you complete the Basic Information step.
- When available, click the **Compact Printable...** link in the Other Actions section to print a compact (typically one page, based on document content) version of the original printable document. The compact document contains only pertinent information from the authorization or voucher. Print the standard document to see all available information.

#### **System-Generated Document**

The system generates a printable record of the financial system transactions associated with a document at final document approval. You can view the Financial System Transaction File from a document's Summary page. The viewed PDF file can be printed or saved.

# Printable Profile

The printable profile is a printable version of a traveler's E2's user profile.

### Privately Owned Vehicle

Privately owned vehicle (POV) refers to any vehicle owned privately, such as a car, truck, motorcycle, or even an airplane. E2 supports the following default POV modes of transportation:

- Private Auto
- Private Motorcycle
- Private Plane

### **POV Expense Types**

The following are the default POV expense types and subtypes:

- Private Auto Mileage Govt Auto Available A government-owned automobile is available for use. The employee would not ordinarily be authorized to use a privately owned automobile, due to the availability of a government automobile, but nevertheless requests to use a privately-owned automobile.
- **Private Auto Mileage Private Auto Authorized** An employee is authorized to use a privately- owned automobile.
- Private Motorcycle Mileage
- Private Plane Mileage

To add a privately owned vehicle expense to an authorization, voucher, or local travel claim, access the Expenses step in the workflow, and then click the **Add New Expense** link. Select the POV expense type from the **Expense** drop-down list, enter the distance traveled in miles or kilometers, and E2 will calculate the reimbursable amount.

**TIP**: You can also indicate POV as the mode of transportation for your trip by selecting Private Auto, Private Motorcycle, or Private Plane from the **Mode of Transportation** drop-down list on the Site Details step in the authorization workflow. If you select Private Auto, you will need to select the Government Auto Available or Private Auto Authorization subtype when you add the estimated expense to the authorization.

## **Profile**

The E2 user profile is a record of information about a traveler, provided by federal agencies and their employees, that contains basic identifying elements, including, but not limited to:

- Traveler name
- Email address
- Agency name
- Traveler's work address and phone numbers
- Charge card information
- Accounting or payment information
- Travel preferences, including frequent traveler memberships and loyalty numbers.

#### **Complete Your Profile**

Before you can use E2 to create your travel plans, you must complete the information in your E2 profile. Your E2 profile is initially set up for you and includes some basic information. When you first log on to E2, you should review and, if necessary, complete the information in your profile.

- 1. Click the User Options menu in the task bar (i.e., your name).
- 2. Select *Profile* from the drop-down list. This displays the User Profile page.
- 3. Click on the available links to edit sections of your profile.

#### TMC Travel Profile

E2 maintains some information in your user profile, while other information is stored in your TMC travel profile. Click the **Edit Travel Preferences** link to update TMC profile information, such as frequent traveler membership and other loyalty numbers.

If the Edit Travel Preferences link is not available in your E2 profile:

- You are missing required profile information, such as address information or credit card information. (Your profile must include address, phone number, and email information. Your travel policy may also require you to enter travel charge card information.)
- Your agency's travel policy does not allow online booking. Contact your internal agency help desk or E2 administrator for further assistance.

### Profile Supplement

The Profile Supplement page allows you to enter optional information that can be added to your E2 user profile. If the optional information exists, it can be used for reporting purposes.

### Proportional Meal Rate

#### **NOTE**: The Proportional Meal Rate (PMR) is a JTR-only travel policy item.

The proportional meal rate (PMR) is the rate used when one or two government meals are available or provided at no cost to the traveler. The PMR is the average of the <u>government meal rate (GMR)</u> and the locality meal rate, rounded up to the nearest whole dollar.

#### **GMR/PMR** Reimbursement Type

You can select the *GMR/PMR* option from the **Reimbursement Type** drop-down list in the authorization's Meals and Incidental Expenses window for each day for which the government meal rate is applicable. When selected, the following changes are made to the corresponding fields in the data grid:

- The **M&IE Amount** field defaults to the government meal rate (GMR) amount plus the local incidental per diem rate for the specific date.
- The **Breakfast Provided**, **Lunch Provided**, and **Dinner Provided** check boxes are checked, but remain enabled.
- The **Notes** field is set to *GMR*.

If one or more of the **Provided** check boxes is cleared, the **M&IE Amount** field defaults to the proportional meal rate (PMR) plus the local incidental per diem rate for the specific date, using current PMR calculations, and the **Notes** field is set to *PMR*.

### **Reclaim Voucher**

See Voucher Type.

#### **Reduced Per Diem**

The *Reduced* reimbursement type allows you to reduce the reimbursement to a specific rate that is lower than the standard per diem rate. After selecting *Reduced* from the **Reimbursement Type** drop-down list, enter the reduced rate in the **Amount** field in the Lodging Expenses window and/or the **M&IE Amount** field in the Meals and Incidental Expenses window. For example, a *Reduced* per diem reimbursement type could be used to claim zero (0.00) lodging for a specific day.

#### Per Diem Meals and Incidentals

When you select *Reduced* as a reimbursement type for meals and incidentals (M&IE), the amount entered in the **M&IE Amount** field must be less than the total of the amounts shown in the **Per Diem Meals** and **Per Diem Incidentals** fields.

### Reimbursement Type

Reimbursement type refers to the kind of reimbursement you are requesting, such as per diem or actual expenses. Reimbursement types are selected during the Expenses step of the authorization's workflow. You select a reimbursement type for daily lodging, meals, and incidental expenses. The reimbursement type you select controls the amount of expenses you can enter for the trip.

The following reimbursement types are available (based on your agency's travel policy) from the **Reimbursement Type** drop-down list in the Lodging Expenses and Meals and Incidental Expenses windows.

- Actual The actual expense for lodging or meals and incidental expenses (M&IE).
- **No Expenses** Select this option to submit the authorization, voucher, or local travel claim without any lodging and/or meals and incidental expenses.

**NOTE**: The No Expenses reimbursement type must be enabled for travelers at the office or workgroup (minor customer) level.

- **Per Diem** The daily payment used to reimburse a traveler's lodging, meals, and related incidental expenses, based on established per diem rate tables.
- **Reduced** A reduced rate that is lower than the standard per diem rate for a site.

### <u>Remarks</u>

Remarks are comments or instructions to others concerning an authorization, voucher, or other travel document. For example, a traveler could add a comment to an approver about a specific expense, and an approver could add an instruction to the traveler when returning a travel voucher for modification. Each document includes all remarks related to that trip or local travel claim, including remarks associated with specific estimated or actual expenses.

In some cases, remarks are required. For example:

- If an approver returns an authorization to a traveler for revision, certain reasons for return require the approver to add remarks to the document.
- If an approver reduces an expense on a voucher, the approver is required to enter a remark for the reduced expense.

#### Add a Remark

To add a remark to a document or to view all document remarks, open the document, and then click the **Remarks** link in the Other Actions section.

### **Reservation Name**

Your reservation name is the name used for all of your commercial airplane reservations and by the Transportation Security Administration (TSA) for watchlist screening. This name <u>must</u> match the government-issued documentation you will use when traveling (e.g., passport, driver's license).

**TIP**: Since your reservation name may be different from your traveler name, you should verify and update your reservation name information in your user profile before booking travel in E2.

### **Retained Advances**

If an advance cannot be liquidated, the traveler is responsible for returning the balance of the advance outside of E2, unless the traveler's financial system permits retained advances. If retained advances are enabled and the traveler is unable to fully liquidate an advance on the final voucher for the trip because of insufficient traveler-reimbursable expenses, the traveler can retain the advance and liquidate it on subsequent vouchers for any trip.

#### **Rules**

The following rules apply to retained advances:

- All outstanding advances must be liquidated, if possible, on the final travel voucher before it can be submitted for approval.
- Each time you create and submit a voucher, E2 automatically calculates the advance amount that has not yet been liquidated for the current trip, the total "pay to traveler"

expenses that can be used to liquidate the advance, and the total amount of retained advances.

- If this is not a final voucher, you must enter the advance amount to liquidate. The maximum amount to liquidate is the lesser of the advance amount outstanding for the current trip plus the total of all retained advances or the total of all expenses reimbursable to the traveler. You can liquidate a smaller amount, if necessary.
- If this is a final or supplemental voucher, you must liquidate the lesser of the advance amount outstanding for the current trip or the total of expenses reimbursable to the traveler. If you have sufficient expenses reimbursable to the traveler, you can liquidate up to the total of the advance amount outstanding for the current trip plus the total amount of retained advances available for liquidation.
- E2 liquidates retained advances on a FIFO basis (first-in first-out), based on the approval date. Travelers cannot select a specific retained advance for liquidation.

### Routing Pool

A routing pool contains the names of the approvers that can approve a travel document. Multiple routing pools can be created to support multiple levels of approval. Routing pools are used in conjunction with routing rules. Routing rules define triggers that route a travel document for approval and are typically contained in routing templates. A routing pool is assigned to each routing rule in a routing template or each routing rule that is applied directly to a specific user.

#### **Minor Customers**

A default routing pool can also be associated with a minor customer. E2 recommends assigning each minor customer a default routing pool that can be used to approve trips when a trip does not conform to any defined routing rules. E2 also recommends that the default routing pool be comprised of users with an E2 role of administrator who can respond to the pending approval email notification and modify the trip's routing path, preventing delays to the traveler.

### Routing Template

A routing template contains the routing rules that are used to route travel documents for approval in E2. A travel document uses the routing rules that are currently defined for its document type.

### Safe Haven

A safe haven is a temporary location to which the employee and their dependents are sent in the event of an evacuation.

### **Shared Lodging**

Shared lodging is when you share lodging when another person while on TDY travel.

#### Lodging Expenses

In E2, the **Shared** check box in the Lodging Expenses window allows you to indicate the traveler is sharing lodging with another person. Selecting the **Shared** check box documents the information for the approver and auditor; it does not change the traveler's entitlements. The traveler should manually reduce the lodging rate as required by the Federal Travel Regulation.

- If the traveler is sharing the room with another government employee on official travel, the traveler is limited to 50% of the double occupancy rate.
- If the person sharing the room is not a government employee on official travel, the traveler is limited to the single occupancy rate.

**NOTE**: Refer to FTR <u>\$301-11.13</u>, "How does sharing a room affect my per diem reimbursement?" for more information.

### Ship Per Diem Sites

A ship can be added as a standard or custom, CONUS or OCONUS per diem site in E2 to ensure an authorization correctly identifies a traveler's TDY orders and reimbursements. This ship "site" can then be selected on the authorization or voucher Site Details page, just as you would a regular travel site.

**NOTE**: Contact your CWTSatoTravel program or implementation manager for more information about configuring a ship site for E2.

#### **Embarkation & Debarkation Reimbursement Rates**

Ship sites are typically added with \$0.00 Daily Lodging and M&IE per diem rates to reflect how these expenses are reimbursed for time spent aboard a ship. The embarkation (i.e., arrival at the ship) and debarkation (i.e., departure from the ship) days, however, will be entitled to either full or partial reimbursement, based on the arrangement of the trip and the time spent in port.

#### Example #1

Let's say, on September 1, you travel from your home site of Chicago, Illinois, to the port in Norfolk, Virginia, and immediately board the ship. In this scenario, you will receive:

- \$0 per diem for lodging
- 75% of the M&IE per diem rate for Norfolk

**NOTE**: E2 looks at the embarkation and debarkation ports (i.e., the sites just before and after the ship site) to determine the appropriate per diem rate to apply for each day.

The same amounts will be incurred on September 8, if you debark the ship in Norfolk and immediately travel home to Chicago.

#### Example #2

You are entitled to more in the way of per diem if you spend time in port before boarding or after leaving the ship. Let's say, on November 1, you travel from your home site of Denver, Colorado,

to San Diego, California. You board the ship in San Diego on November 2, debark at the port on November 8, and then return to Denver on November 9. In this scenario, you will receive:

- 100% of the standard lodging per diem rate for San Diego on November 1 and 8 (i.e., the days you are in the city), but \$0 for November 5 and every day that you are on board the ship.
- For M&IE:
  - 75% of the standard M&IE rate for San Diego on the first (11/1) and last days (11/9) of the trip. (This is standard practice for all trips, regardless of whether a ship is involved.)
  - 100% of the M&IE rate for San Diego on the ship embarkation (11/2) and debarkation (11/8) days.
  - \$0 in M&IE for each day you are on board the ship.

### Specific Travel Purpose

The traveler's description of the purpose of the trip. This field is part of the authorization's Basic Information page.

### <u>Spouse</u>

A spouse, husband, or wife; all words to describe that the employee and another individual are lawfully married to each other where that marriage is legally recognized.

See also Domestic Partner.

#### Standard Account Code

Standard accounting uses codes that are pre-built strings of segments provided by your agency's financial system. Users select standard account codes to fund travel expenses from the set of codes available to them.

### Supplemental Voucher

See Voucher Type.

### <u>T & O</u>

See Transportation and Other Expenses.

### <u>Task Bar</u>

The task bar displays at the top of each E2 page. Task bar selections vary, depending on your user type and role, and the activity you are currently performing (e.g., arranging travel for another user).

#### My E2, My Approvals, Travel for Others, Reports, User Options

The following options display in the task bar for all users. (The *My Approvals* option has expanded functionality for users with the type of *Approver*.)

- **My E2** Click this option to access the **At a Glance** tab, as well as other tabs that show your trips, local travel claims, open and group authorization lists.
- **My Approvals** Click this option to approve travel documents (if you are an approver) or to review travel documents that were prepared for you by an arranger (all users).
- Travel for Others Click this option to begin a travel arranger session for another user.
- **Reports** Click this option to generate on-demand travel reports.
- User Options (i.e., your name) Click this menu to view or update your E2 profile (*Profile* option), access the Message Center (*Message Center* option), access online help (*Online Help* option), or log out of E2 (*Logout* option).

#### **View Documents**

Click **View Documents** in the task bar to view the travel documents of other users. (Only available to users with specific permissions.)

#### Traveler's Trips/Traveler's Profile

The **Traveler's Trips** and **Traveler's Profile** task bar options display for travel arrangers when arranging travel for another user. These are the only items that appear in the task bar when arranging travel for another user (known as an arranger session).

- Click Traveler's Trips to see the traveler's At a Glance, Trips, Local Travel, Open Authorization, and Group Authorization tabs.
- Click Traveler's Profile to view and update the traveler's user profile.

#### Audit

Click Audit in the task bar to perform audits of travel documents (auditors only).

#### Administration

Click **Administration** in the task bar to access all administration tasks available to you. Tasks may include:

- User maintenance
- Approval routing management
- Charge card management
- Customer settings
- Financial settings
- Messaging settings

### **Temporary Duty Location**

A temporary duty location (TDY) is, per the Federal Travel Regulation, "a place, away from an employee's official station, where the employee is authorized to travel."

# <u>Tips</u>

You can normally include tips for transportation, as well as tips at terminals for government equipment baggage handling, in your travel expenses. Other types of transportation-related tips, such as tips for taxi, shuttle service, or courtesy transportation, may be reimbursable depending on applicable travel policy.

**TIP**: Travel policies differ. If you have questions about what expenses are reimbursable or the tip amount allowed, contact your supervisor or travel policy manager.

# <u>TMC</u>

See Travel Management Center.

### TMC Fee

The TMC fee is a fee that is applied by your travel management center (TMC) when processing and ticketing your reservation. This fee varies based on the complexity of the reservation and the involvement by the TMC. Typically, the TMC fee is less if you made the reservations online via E2, and if it did not require travel agent assistance.

#### NOTE: Contact your program manager for more information on the actual fees assessed by your TMC.

Your TMC fee is shown on the invoice that is sent to you by your TMC, based on your agency's ticketing agreement.

- If you need a copy of the invoice and we are your contracted TMC, contact us and select the option for a travel counselor for further assistance. Be prepared to provide the traveler's name and reservation confirmation code, if available.
- If we are not your TMC, contact your contracted TMC agency (e.g., AdTrav, El Sol, National Travel) for further assistance.

### What to Do With the TMC Fee in E2

The TMC fee should be added as an expense to the travel voucher for the trip. You can also estimate this expense by adding it to your travel authorization. Each trip that includes reservations should have one TMC fee. You should include the TMC fee as an expense even if your TMC made all travel bookings for you and you did not use the E2 online booking tool.

The TMC fee is a non-refundable fee. If your reservation was ticketed, but your trip was then canceled, the TMC fee is still assessed. When you cancel your trip in E2, select the option that cancels the reservation, but allows you to submit out-of-pocket expenses for reimbursement.

Agency travel policy controls the disbursement of the TMC fee. It is generally disbursed to the same method of payment as used for your airline reservation (or for your hotel guarantee).

### TMC Travel Profile

Your TMC travel profile is a profile of traveler information retained by the online booking tool. The TMC profile ID is available in your E2 profile and becomes part of every reservation. A TMC profile is only required for users who are allowed to book reservations online via E2.

### Transportation and Other Expenses

"T&O" refers to transportation and other miscellaneous expenses. These expenses are added to authorizations and vouchers via the document workflow's Expenses step. Lodging, meals, and incidental expenses are not part of "T and O" expenses; airfare, rental car, and conference fees, for example, would be considered T&O expenses.

#### Audit

Some travel policies have established limits for T&O expenses. Vouchers that exceed this limit may be subject to audit.

### Travel Arranger

A travel arranger is a user who can make trip arrangements, or take other actions, for another user via the Travel for Others feature. If you are frequently unable to access the web, a travel arranger can be helpful.

- Travelers can select other users to perform travel arranger functions on their behalf in their E2 user profile. These users are referred to as *designated travel arrangers*. As a designated travel arranger, you can arrange travel for the person who selected you as an arranger. (You can be a designated travel arranger for one person or multiple people.)
- Your office, workgroup, or agency may permit select users to arrange travel for travelers within their group, without being designated as an arranger in each traveler's E2 user profile. A user with this permission has the role of arranger and will see enhanced filter options on the Travel for Others page.

### Travel Authorization

A travel authorization is an approved request to travel on official business. There are three basic types of authorization:

- Open authorizations that allow you to travel for any official purpose without further approvals.
- Open authorizations that allow you to travel for any official purpose without further approval under specific conditions. Limitations may include geographical locations, individual or total trip cost ceilings, periods of time, etc.
- Trip-by-trip authorizations (also known as "TDY authorizations") allow you to travel for a specific purpose, itinerary, and costs. This includes travel under a group authorization.

**TIP**: See the definition of Travel authorization (Orders) in section  $\frac{\$300-3.1}{10}$  of the Federal Travel Regulation.

### **Travel Justifications**

Travel justifications allows you to specify the reason you booked a reservation that is considered outside the agency's travel policy. Travelers may be required to select a justification for their out-of-policy travel during the online booking process, and they are required to select justifications as needed from the authorization's Travel Policy page.

### Travel Less Than 12 Hours

There is no per diem allowed for travel of 12 hours or less. You will not be reimbursed for per diem expenses if your official travel is less than 12 hours in length.

### Travel Management Center

The travel management center (TMC) is the travel agency that provides travel services for your group, such as CWTSatoTravel, AdTrav, or CI Travel.

### Travel Policy Manager

See Administrator.

### Travel Preferences

Travel preferences refers to selections such as frequent flyer and other loyalty programs, passport and visa information, preferred meal selections for flights, etc. Travel preferences are retained in the traveler's TMC profile.

### <u>Traveler</u>

A traveler is a person who may travel on a government aircraft because they meet one of the following criteria:

- A civilian employee in the government service
- A member of the uniformed or foreign services of the United States government
- A contractor working under a contract with an executive agency

#### Arranging Travel

Travelers can manage travel documents for their own travel. As a traveler, you can also perform these actions for other travelers who have given you permission to arrange their travel. In E2, any user, regardless of user type or role, can perform traveler and travel arranger functions.

Travelers select other users to be their travel arrangers in their profile. Certain users within a workgroup, however, may be designated as arrangers for all travelers within their group; they can automatically arrange travel for others without traveler selection.

### Traveler Name

Your traveler name is the name that identifies you in E2. Your "traveler name" displays at the top of your user profile and as the label for the User Options menu in the task bar. This name is also used by your agency's financial system.

**NOTE**: The traveler name cannot be changed. If it is incorrect, contact your travel policy manager or E2 administrator for assistance.

# <u>Trip ID</u>

A unique identification number assigned by E2 to each travel request. The trip ID is associated with all trip documents and is automatically assigned after you complete the Basic Information step in the authorization's workflow. Once assigned, the trip ID cannot be changed. When you cancel a trip, the trip ID is also canceled and will never be reused.

# <u>Trips</u>

A trip is a set of travel plans for a specific government traveler. The term "trip" encompasses all documents related to travel, including authorizations, advances, reservations, and vouchers. E2 supports the creation of the trips outlined below.

#### **Group Authorization**

A group authorization is a request for a trip for two or more E2 users. For example, if an engineering department needs to attend a conference, you can create a group authorization and assign identical destinations for all travelers in the group. Group authorizations in E2 have a *GA* prefix.

#### Local Travel Claim

Local travel is typically defined as travel that occurs within a 50-mile radius of your home site. You can request reimbursement for items such as mileage, tolls, tips, parking, and other expenses through a local travel claim. You cannot, however, request reimbursement for hotel charges or ticketed transportation.

Local travel claims in E2 have an *LT* prefix.

#### **Open Authorization**

An open authorization is a blanket authorization covering specific travel requests for up to one year. After the open authorization (OA) has been approved, all future specific travel requests that are created under the blanket authorization, and meet any blanket authorization limitations, inherit the approval status of the open authorization. An open authorization can be one of the following:

- Limited OA A limited open authorization has specific dollar amounts or destination restrictions.
- Unlimited OA An unlimited open authorization does not have specific dollar amounts or destination limits.

Open authorizations in E2 have an OA prefix.

#### **Travel Authorization**

A travel authorization is a request for a trip, or a series of trips, with start and stop dates. A travel authorization can be a single trip authorization, or it can be created under a group or open authorization.

A travel authorization can contain temporary duty (TDY) locations, rest stops, or authorized delays, and all authorizations can include non-federally sponsored expenses. (Refer to Section 301-11.20 and other sections of the <u>Federal Travel Regulations (FTR)</u> for information about rest stops and authorized rest periods.) You identify your itinerary, including mode of transportation, hotel, and rental car, as well as estimated expenses and fees.

Your authorization must be approved before you can travel. After your travel is complete, you create a voucher to submit your travel expenses for payment.

## Type of Travel

The **Type of Travel** field contains a list of all types of travel configured for the agency. Selection is made from the list provided on the authorization or local travel claim's Basic Information page.

### Unused Transportation

You are not authorized to receive a refund, credit, or any other negotiable document from a carrier for unfinished services or any portion of an unused ticket issued in exchange for a GTR or billed to an agency's centrally billed account. Any charges billed directly to your individually billed travel charge card, however, will be credited to your credit card.

### Expense Type

If you have an unused airline ticket value, you can add an *Unused Ticket* expense with a negative value to your authorization (or voucher).

### <u>User Roles</u>

User roles provide users of any type with access to specific features and functions. User roles are assigned to a user of any type during the initial user configuration process. For example, a user with a user type of *Approver* can also have the role of *Arranger*.

The following user roles can be assigned to a user of any type.

#### Arranger

Travelers can designate any user within their group as someone who can arrange travel for them. If you have the user role of *Arranger*, however, you can arrange travel for any other user to whom you have access, without having to be designated as a travel arranger by specific travelers.

Arrangers are identified as any user with an arranger access level of minor customer (or higher). The arranger access level controls the group of users for whom you can arrange travel automatically. For example, if you have an arranger access level of major customer, you can arrange travel for any user within your own workgroup and within any other workgroup associated with your major customer. (The **Arranger Access level** field is part of your user account settings and is managed by an E2 travel policy manager.)

As an arranger, you can view a list of all users for whom you can automatically arrange travel by clicking **Travel for Others** in the E2 task bar.

### Charge Card Manager (Card Coordinator)

Charge card managers are identified as any user with a Charge Card Management access level of minor customer (or higher). As a federal agency program coordinator, you can manage central billing account cards (CBAs), update expiration information, and change the status of users' travel charge cards (TCCs). You can also view card history and restrict TCC usage.

### Self Registration Validator

Validators are identified as any user with a Self Registration Validator access level of minor customer (or higher). As a validator, you validate user requests for E2 user accounts.

#### **Travel Policy Manager**

Travel policy managers are identified as any user with an admin access level of minor customer (or higher) and any administrator permission settings. As a travel policy manager, your admin access and associated administrator permissions provide you with the powers of a federal system travel administrator and may include the ability to:

- Create, delete, and manage user accounts and user profiles
- Define major and minor customer settings
- Add nodes to, and remove nodes from, the customer hierarchy
- Manage approval routing pools, routing rules, and routing templates
- Manage financial systems, accounting codes, and funds
- Customize informational messages and emails, and manage user bulletins

### <u>User Types</u>

E2 provides each system user with access to features and functions appropriate to a specific user type and role. All users are assigned a user type during the initial user configuration process. E2 supports the following user types:

- **Approver** As a federal supervisory travel approver, you can approve, revise, route, and print travel documents, including vouchers, local travel claims, advances, and amended documents, with comments and accounting functionality.
- Auditor As a federal agency auditor, you can approve or revise a travel voucher or voucher amendment (with comments). If you are performing post-payment audits, action is limited to approval.
- **Traveler** As a federal traveler, you can create, modify, delete, route, and print travel documents for yourself, as well as for any other travelers who have given you permission to arrange their travel. Any user, regardless of user type or role, can perform traveler or designated travel arranger functions.

### Variable Per Diem Rates for Standard Sites

Workgroups can configure variable per diem rates for standard sites based on the length of the trip or based on the type of travel and length of that trip. Variable per diem rates are a percentage of the standard per diem rate. They can be individually configured for:

- First Day Percent Meals Percentage of the Meals per diem rate applied to the first day of the trip and the first day back from a break
- First Day Percent Incidentals Percentage of the Incidentals per diem rate applied to the first day of the trip and the first day back from a break
- Last Day Percent Meals Percentage of the Meals per diem rate applied to the last day of the trip and the last day before a break
- Last Day Percent Incidentals Percentage of the Incidentals per diem rate applied to the last day of the trip and the last day before a break
- Other Days Percent Meals Percentage of the Meals per diem rate applied to all trip days other than the first and last, as identified above
- **Other Days Incidentals** Percentage of the Incidentals per diem rate applied to all trip days other than the first and last, as identified above
- Lodging Percent Percentage of the Lodging per diem rate applied to all days where lodging is allowed

If your trip is subject to variable per diem rates, the Notes column in the Lodging Expenses and Meals and Incidental Expenses windows, as well as the Other Information column on the View Daily Expenses window, includes the keyword *Variable*, followed by the percentage of the standard per diem rate applied to lodging, meals, and incidentals for the day.

**NOTE**: Variable per diem rates apply automatically, based on your workgroup's configuration. As a traveler, you cannot make changes to any per diem or variable per diem rates for your travel.

# <u>VATT</u>

See <u>Verbal Authorization to Travel</u>.

### Verbal Authorization to Travel

VATT is an acronym for Verbal Authorization to Travel. VATTs are created when you are given direction to travel, but you cannot create an authorization or make online reservations prior to your travel date. After you complete your travel and return home, you can create an authorization using the actual travel dates, which have passed, and file a voucher for your trip.

**NOTE**: Travel policy controls your ability to create VATTs. If you attempt to create an authorization for past dates but receive an error message that indicates the dates selected are not allowed, your travel policy does not support the creation of VATTs. Contact your travel policy manager for assistance.

### <u>Voucher</u>

A travel voucher is similar to an expense report for your travel. After an authorization has been approved and your travel completed, you can submit your expenses for reimbursement by creating a voucher and submitting it for approval and payment.

TIP: Refer to the definition of Travel claim (Voucher) in section §300-3.1 of the Federal Travel Regulation.

### Voucher End Date

When you create a voucher, the voucher covers expenses from the first day of travel through the date specified in the **Claim Expenses Between End Date** field on the Voucher Basic Information page. The claim expenses end date (also known as the *cut-off date*) is the last day of expenses that can be claimed on the voucher. By default, this is the last day of the trip.

In many cases, you will have only a single voucher for a trip, so the default cut-off date is appropriate. If you have length travel, however, or a temporary reassignment of duty station, you may prefer to submit expenses for a specific time period. For example, if you have travel that lasts 90 days, you may prefer to submit a voucher to cover the first 30 days, another to cover the next 30 days, and the final voucher to cover expenses through the last day of travel. You can do this by changing the end date for each voucher that you submit.

**Example:** Suppose you have a trip that begins on 1 October, ends on 31 December, and you want to submit expenses on a monthly basis. When you create the first voucher, you would select an end date of 31 October. E2 limits the expenses list for the voucher to only those expenses that were incurred on or before 31 October. When you create the next monthly voucher, you would select an end date of 30 November. E2 automatically limits the expenses list for that voucher to any unclaimed expenses that were incurred on or before 30 November. Allowing the end date for the last voucher to default to the last day of travel enables the voucher to cover any unclaimed expenses that were incurred during the trip.

#### Rules

The following rules apply to voucher end dates. (Special rules apply to pre-trip and supplemental vouchers.)

- The date cannot be prior to the first day of travel (unless you are submitting a pre-trip voucher).
- The date cannot be after the last day of travel.
- The end date for a voucher cannot be after the end date of a subsequent voucher.

**EXAMPLE**: If you have two vouchers, the end date for the first voucher cannot be later than the end date for the second voucher. If your trip is 10/1 through 10/30, and voucher 2 has an end date of 10/20, voucher 1 must also have an end date of 10/20 or earlier.

• The voucher end date cannot be before the end date of the previous voucher.

**EXAMPLE**: If you have three vouchers, the end date for the third voucher cannot be before the end date for the second voucher. If your trip is 10/1 through 10/30, and voucher 2 has an end date of 10/15, voucher 3 must also have an end date of 10/15 or later.

• Even if leave (i.e., official day off) was taken on your last day(s) of travel, the voucher end date selected on your final voucher should still be the last day of your trip (as initially indicated on the authorization).

#### **Pre-Trip Vouchers**

For pre-trip vouchers, the **Claim Expenses Between End Date** field (i.e., voucher cut-off date) must be on or before the current date, and cannot be after the trip start date or before the date the authorization was approved. The field defaults to the current date.

#### Supplemental Vouchers

The Voucher Basic Information page for a supplemental voucher does not allow changes to the voucher cut-off date. The **Claim Expenses Between End Date** field defaults to the last day of the trip and cannot be changed.

#### Amendment

If your last day of travel has changed (e.g., you returned from your trip a day early), you must amend the authorization before you submit your voucher (unless your group's travel policy permits itinerary changes on a final voucher). Depending on your agency policies, minor authorization amendments may receive automatic approval.

### Voucher Finality

For all incremental vouchers, you select voucher finality on the Voucher Basic Information step. You should identify each voucher you create as a *Not Final* voucher in the **For this trip this is the** field, until you create the last voucher to cover the trip expenses. When you create the last voucher, you should select *Final* (or *Final Voucher and Update Site Details*) from the **For this trip this is the** drop-down list.

#### Rules

The following rules pertain to voucher finality.

• You can change the finality at any time before you submit the voucher for approval (unless you selected *Final Voucher and Update Site Details*).

**NOTE**: If your group allows itinerary changes on a final voucher, you have the option to select Final Voucher and Update Site Details on the Voucher Basic Information page from the **For this trip this is the** drop-down list. You cannot change this selection after it is made; you must delete the voucher and start again.

- After the voucher has been submitted for approval, its status changes to *Pending Approval*; you cannot make changes to any document with a *Pending* status. You can, however, recall a voucher that is pending approval. After recalling the voucher, you can change the finality and resubmit it for approval.
- If the voucher has been approved, and you did not indicate that the voucher was a final voucher, you can change the finality of the voucher by closing the trip. If a final voucher was approved but you need to submit additional expenses, return to the Trip Dashboard, and then click **Create Voucher** to create a supplemental voucher. (If this option is not available to you, contact your travel policy manager for assistance.)
- If the voucher is returned to you for revision, you can change the voucher's finality on the Voucher Basic Information page, make any other changes as needed, and then resubmit the voucher for approval.

# Voucher ID

The voucher ID is the sequential number associated with the voucher (e.g., 1, 2, 3).

### Voucher Payments

You will receive an email when your voucher is approved for payment, as well as an email when your group's financial system makes a payment to you.

- You can check the status of the voucher on your Trip Dashboard. A voucher with a status of *Awaiting Payment* has received all approvals necessary for payment.
- You can open the voucher and click the **View Payments** link in the Other Actions section to review the payment history.

**NOTE**: Contact your financial department for additional information about voucher payments, including bank account and other payment information.

### Voucher Status

The voucher status is the status of the voucher request, similar to the authorization or trip status. A voucher's status is displayed in the header of each voucher.

### Voucher Transaction Fee

A voucher transaction fee (VTF) is a processing fee that is automatically charged when you use E2 to complete a voucher. This fee is automatically applied once to each voucher and local travel claim, including zero-dollar vouchers. The addition of an estimated VTF to an authorization, as well as the addition of a VTF to each voucher, is handled by the system; you cannot add additional VTFs or make any changes to existing VTFs.

#### **Disbursement**

The VTF is automatically disbursed based on your agency's travel policy and cannot be changed.

- If the VTF is disbursed to your government-issued travel charge card, the fee will be included within your voucher reimbursement and is typically disbursed directly to your travel charged card. The fee will usually appear on the credit card statement within one to ten business days after the voucher is closed.
  - Before a charge for VTF is made to a travel charge card, verification is made to ensure the fee has not previously been charged for the trip or voucher.
  - The VTF charge may appear later than the ten days specified above, if there was an issue charging the travel charge card with the fee. For example, if the card had an invalid expiration date on the day when the charge was attempted, the VTF charge may actually appear weeks after your voucher was approved or paid.
- If the VTF is set by your agency to disburse to "agency billed," you will have little interaction with this fee. It is simply listed on the appropriate travel documents.
- The VTF charge will never be applied to a personal credit card.

**NOTE**: If you have any further questions regarding VTFs, contact your agency's internal help desk or agency system administrator.

### Voucher Type

In E2, a voucher is an accounting of expenses for a specific trip and a request for reimbursement. E2 supports the creation of the following types of vouchers.

- **Pre-trip** A pre-trip voucher is a request for reimbursement for pre-trip expenses, such as conference fees or other items that require payment before travel occurs. If this voucher type is enabled, a trip can have multiple pre-trip vouchers, and the **Create Pre-Trip Voucher** button displays on the Trip Dashboard.
- Incremental An incremental voucher is a request for travel expense reimbursement for a specific trip. A trip can have one or more incremental vouchers. Click **Create Voucher** on the Trip Dashboard to create a voucher. E2 determines if the voucher is incremental or final based on the information you enter on the Voucher Basic Information page.
- **Reclaim** A reclaim voucher is a request for reconsideration of a denied or reduced travel expense. When a voucher is approved, but a claimed expense is reduced, the **Reclaim** button displays on the Trip Dashboard.
- Final A final voucher is an incremental voucher that is marked as the final voucher for the trip. Every trip must have, at minimum, a final voucher. Click **Create Voucher** on the Trip Dashboard, and then select *Final Voucher* (or *Final Voucher and Update Sites Details*) from the **For this trip this is the** drop-down list.
- **Supplemental** A supplemental voucher is a request for additional travel expense reimbursement after a final voucher for the trip has been submitted. If this voucher type is enabled, a trip can have multiple supplemental vouchers. E2 creates a supplemental voucher when you click **Create Voucher** on the Trip Dashboard if a final voucher for the trip already exists.

### Rules

The following rules apply to vouchers:

- After an authorization is approved and before the first day of travel, you can create a pretrip voucher.
- When your travel is complete, you can submit a voucher as an account of your travel expenses for approval and reimbursement. Since you do not need to submit all of your expenses for a trip at one time, each trip can have multiple vouchers. Each voucher you submit is an incremental voucher, until you designate a voucher as the final voucher for the trip.
- If a request for reimbursement is reduced or declined, you can request reconsideration of the denied expense by creating a reclaim voucher.
- After the final voucher has been submitted, you can create a supplemental voucher to request reimbursement for additional travel expenses that you missed earlier.
- When you click **Create Voucher** and complete the Voucher Basic Information page, E2 automatically determines what kind of voucher is created (i.e., incremental, final, or supplemental).
